Words of Wisdom from our Grand Knight

DOING WHAT IS RIGHT

We are less than two months away from a national election, and the emails, texts and mail are becoming quite overwhelming. Personally, I have gone from receiving two or three texts daily to over 40. I have no idea how anyone got my phone number, but I am routinely deleting text messages that have anything to do with the upcoming election. The same is true of the numerous “paid political advertisements” that the US Post Office delivers.

As we look to November 5th, I am sure that all of us are ready to fulfill our civic duty and vote. This is not a political statement, rather one of doing what is right as a citizen of the United States of America. While who you vote for is, ultimately, up to your own individual conscience, I do want to make you aware of one specific item which will be on your ballot in November. This one item is a moral issue for all Catholics and we should all be united in opposing Florida Amendment 4.

Florida Amendment 4, the Right to Abortion Initiative, is on the ballot in Florida as an initiated constitutional amendment on November 5, 2024.

A "yes" vote supports adding the following language to the Florida Constitution's Declaration of Rights: "... no law shall prohibit, penalize, delay, or restrict abortion before viability or when necessary to protect the patient's health, as determined by the patient's healthcare provider." Amendment 4 would maintain the current constitutional provision that permits a law requiring parents to be notified before a minor can receive an abortion.

A "no" vote opposes amending the Florida Constitution's Declaration of Rights to provide that the state cannot "... prohibit, penalize, delay, or restrict abortion before viability or when necessary to protect the patient's health, as determined by the patient's healthcare provider."

The Florida Conference of Catholic Bishops have said in their statement regarding Amendment 4:

“Florida Amendment 4, which will appear on Florida's November 2024 ballot, is an extreme proposal that legalizes full-term abortion with no protection for the preborn child, including when the child is capable of feeling pain. This proposed amendment to our state constitution would prohibit all restrictions on abortion before viability and create a broad exception that any healthcare provider could exploit to allow abortion up to birth”

“Furthermore, the amendment would effectively overturn or seriously jeopardize common-sense state laws that have regulated abortion for years. These include basic health and safety requirements for clinics where abortions are performed, requiring a physician to perform abortions, informed consent requirements, laws limiting public funding of abortion, and parental consent requirements before a minor’s abortion. These risks demonstrate the extreme nature of the amendment”

Floridians Protecting Freedom, which describes itself as "a statewide campaign of allied organizations and concerned citizens working together to protect Floridians’ access to reproductive health care and defend the right to bodily autonomy," sponsored the initiative.

The Florida Bishops go on to say: “Human life is sacred. The dignity of the human person is the foundation of a moral vision of society. Direct attacks on innocent persons are never morally acceptable, at any stage or in any condition.”

I strongly suggest, and urge you, as a practicing Catholic man, to fully understand the ramifications of this amendment if passed, and to not only vote against Florida Amendment 4, but also urge your friends, family and others to vote against Florida Amendment 4.

Through Christ Our Lord, Amen.

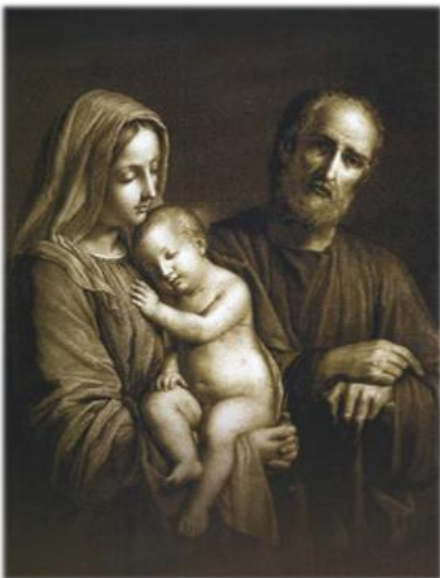

and the Holy Spirit.

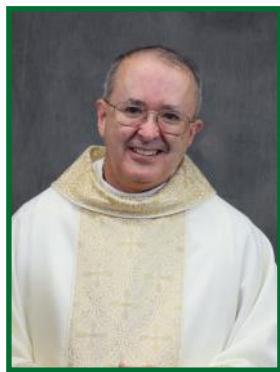
Let your love be evident in the peace that reigns in our home and in the faith, we profess and live. May our family always be a place of generosity, understanding, forgiveness and joy.

Chaplin's Reflection

I am writing this short reflection the day after the anniversary of 9/11 and so I thought that, this month, I would reflect on that anniversary and link it in to what our 4th degree exemplification ceremony says about the importance of patriotism. One of the online dictionary definitions of patriotism says that it is “the feeling of love, devotion, and a sense of attachment to a country or state.” Patriotism is something that, as with everything else, is good when it is in a healthy balance. I, as an immigrant to these shores, look forward to that day when I can make that pledge of allegiance that we say at every meeting as I become a US citizen. It is right and just to be patriotic about our country, or the country of our birth. But, the far end of the patriotism scale can lead to jingoism and exclusion of others not born on these shores, something which is not healthy!

And, when I was looking at patriotism in the Knights, I learned that the first 4th degree exemplification took place on George Washington’s birthday, a deliberate nod to the patriotism that is an important part of being a Knight, and is the pillar of the 4th degree. Those of you who are 4th Degree Knights know the healthy emphasis of patriotism that is part of being a 4th Degree Knight, a patriotism that is far from jingoistic or exclusive, and a patriotism that places country above all else other than God.

I had a blessed vacation with my family this year visiting both Colorado and New York and, one of the sites we visited in New York was Ground Zero, and the 9/11 Museum. I had visited Ground Zero on a number of occasions and, as so often when I visit these national memorials, I’m struck by how tasteful and profound and dignified these memorials are.

But, whilst I had visited Ground Zero a number of times, I had never had the opportunity to visit the 9/11 Museum which was a powerful reminder of the horrors of that day. Both the Memorial and the museum are good examples of what true patriotism is. It is tasteful, profound and dignified and is a patriotic reminder of that awful day, and of the thousands and thousands who were killed on that day and in the decades afterwards. Ground Zero and the 9/11 museum show a healthy patriotism that, rightly, remembers the dead, but doesn’t do so in a jingoistic way. And it shows that the patriotism that is the pillar of the 4th degree can be lived out in our daily lives. May all those who died on 9/11 and in later years rest in peace, and may all their families and friends who still mourn their loss, know God’s peace and God’s comfort.

HAPPY 11th ANNIVERSARY OLMC K of C COUNCIL 15821

As we celebrate our 11th anniversary as a council, we should remember our beginning. Council 15821 was Chartered on October 10, 2013. The primary individuals involved in the start of the council were Sir Knight Larry Kocen, our District Deputy at the time Sir Knight Michael Costanza and our pastor Fr. Fred Tillotson O. Carm. There are forty-seven (47) brothers on the original Charter. Our first Council meetings were held in a classroom at the church. We met there until Tillotson Hall was purchased through the foresight and hard work of Fr. Fred. Members of our council provided much of the labor in the painting and repairing of the hall which was formerly a Baptist Church.

We are on our eighth Grand Knight since the start of Council 15821, and they are:

The officer position of Chaplin is an appointed position and can only be filled by a priest. Our council's first Chaplin was Fr. Bill O'Malley O. Carm. We didn't have Chaplin for a while, although Deacon Tom Grant served as Council Spiritual Director for a number of years. At the present time we are honored to have our Pastor Fr. Anthony Armstrong serving as Chaplin for Council 15821.

Our council has grown from the original 47 to 100 plus members since 2013. We have been active in many charitable functions since our beginning including Citizens with Disabilities (Tootsie Roll Drive), Special Olympics where we provide financial aid and provided volunteers to help with softball, football, basketball and bowling before COVID stopped these activities. Habitat for Humanity is another organization we still support financially and provided volunteers to before COVID.

Council 15821 has earned many Supreme and State awards since its inception. These include Triple Star Council, Double Star Council, Star Council (many times), Membership Achievement, First Place Publicity Activities, First Place Newsletter and Florida Council of the Year.

That is a brief history of our council and as we move forward from our 11th anniversary. I am sure there will be many great and exiting additions to it.

The Soccer Ball Story

SOCCER BALL STORY



I want to share an uplifting story about charity – the story of Chuck Herman, a Fire Chief in Rochester, MN who died in a freak accident on August 4, 2011 while cutting down a tree, having it catch, twist, and fall in a different direction than intended, killing him instantly.

Chuck and his good friend, John, had recently started a non-profit entity called “Great Deeds”, with the idea of performing random acts of kindness, as often as the opportunity arose, with as little as ten or twenty dollars – lunch or groceries for hungry strangers, books, socks, shirts – whatever occasion arose to thank someone or help someone in a small way and for any reason.

Shortly after forming their non-profit, Chuck rode his motorcycle to South Dakota. Stopping at Wall Drug to stretch his legs, he stood in

line to buy a \$20 t-shirt and, while waiting, decided that he already had too many t-shirts. He got back on his bike and continued his journey. In the distance he could see inclement weather approaching so he turned North to avoid it. Several miles out of town he noticed a little white church with lots of cars in the lot. He pulled in and after hearing a wonderful message he shook the pastor's hand and handed him the \$20 bill, suggesting that he take his lovely wife to brunch. The pastor handed it back and directed him to Lily, a parishioner who was about to head to Africa for a two-week mission trip.

Lily was about to use her valuable vacation time to volunteer at an orphanage in a small city in Zimbabwe, bringing clothing, donations, and Bibles. After a short chat Chuck handed her the \$20 bill and instructed her to buy soccer balls for the kids to play with. She reluctantly agreed, thinking the \$20 would be better spent on something else when there was so much need. Chuck doubted the money would end up where he requested but finished his vacation and returned to Rochester.

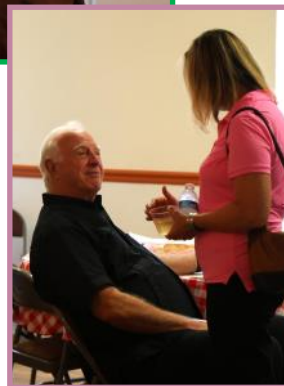
Lily arrived at the orphanage, met the director, and saw all the latest improvements. She advised the director of the promise to buy soccer balls for the kids and he balked at the idea, saying it was too dangerous. She pointed to the adjacent lot and asked him about using that space. Still, he cited that it was too dangerous as the lot was full of broken glass, sharp objects and needles. She then volunteered to clean it up herself and he finally agreed. As she began to clear the lot of debris others pitched in to help. The director drove her to the local sporting goods store to purchase the balls. On the way, Lily noticed some idle earthmoving equipment. She persuaded the director to pull over and she asked the owner/operator to clear the lot for them. He declined, stating that he didn't do charity work. When they arrived at the store there was "Closed" sign in the window. Lily knocked incessantly until someone came to unlock it. The owner pointed to the sign and said that he was going out of business. She pleaded with him to look for soccer balls. He told her there was a barrel in the back she could look through. There she found three uninflated soccer balls and asked the owner to blow them up for her. Instead, he gave her a pump and an inflating needle and took her \$20.

On the way back to the orphanage she persuaded the director to stop and talk with the equipment operator again. Again, he said "No". She kept this up for two more days and he finally agreed to clear the lot since he had no other work. Not only did he clear it but seeded it with left-over grass seed from another project. Local craftsmen fashioned simple soccer goals and the kids were excited to play soccer on a real field.

Lily returned to South Dakota and as she was planning her next trip two years later, she learned from the director that, since her last visit, word had travelled throughout the area of her efforts and others began renting the facility. They were able to purchase all the supplies, food, clothing, and textbooks they needed to run the orphanage with money left over, all because of her \$20 purchase of soccer balls.

Since then, bleachers and benches have been added, the sporting goods store re-opened, the community is thriving, and the neighborhood is safe. Hundreds of soccer teams from the surrounding area are using the soccer complex and Chuck's donation of \$20 has turned into a million-dollar windfall and soccer facility in a poor town in Zimbabwe, keeping his dream of "Great Deeds" alive.

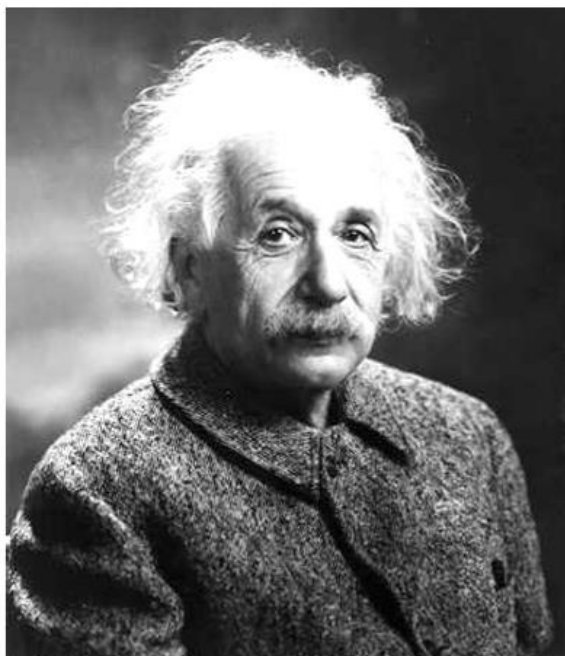

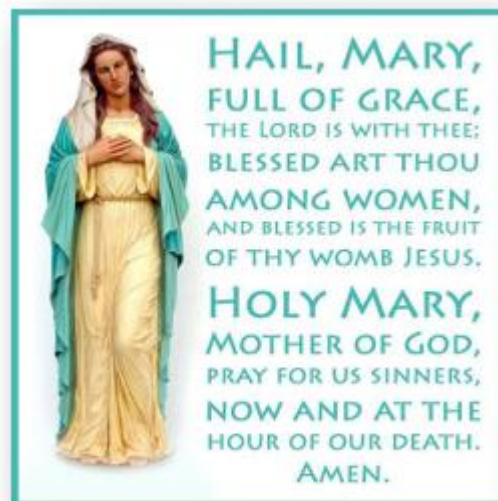

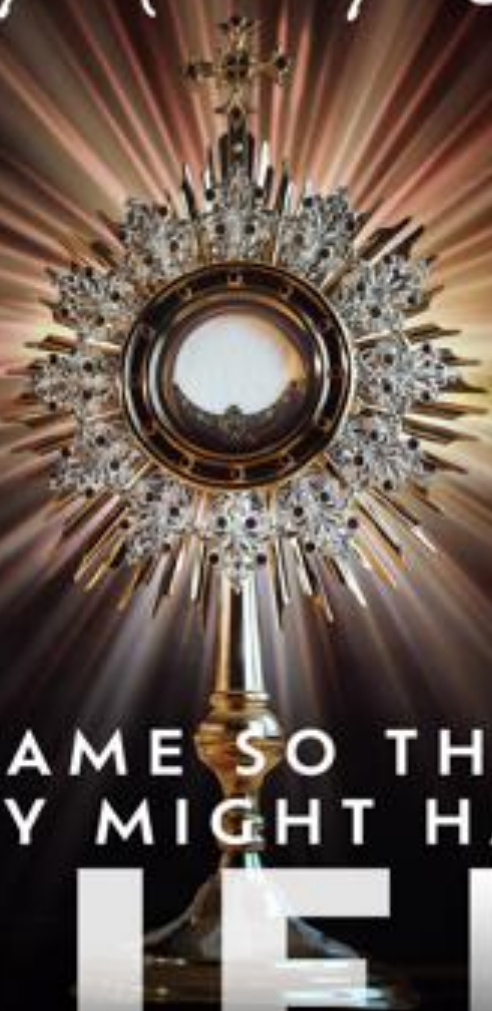

These include basic health and safety requirements for clinics where abortions are performed, requiring a physician to perform abortions, informed consent requirements, laws limiting public funding of abortion, and parental consent requirements before a minor's abortion.¹ These risks demonstrate the extreme nature of the amendment.

We urge all Floridians of goodwill to stand against the legalization of late-term abortion and oppose the abortion amendment. In doing so, we will not only protect the weakest, most innocent, and defenseless of human life among us but also countless women throughout the state from the harms of abortion.

Human life is sacred. The dignity of the human person is the foundation of a moral vision of society. Direct attacks on innocent persons are never morally acceptable, at any stage or in any condition. In our state, human life is repeatedly being destroyed by abortion. Over 84,000 vulnerable and voiceless children were aborted in Florida in 2023.

This matter concerning the respect for human dignity and the fundamental value of human life is of grave importance to both our Church and our state. The threat of abortion remains our pre-eminent public policy priority. Therefore, we support a coordinated campaign to mobilize against the proposed amendment. To this end, we offer this prayer to defeat Amendment 4:

Ever-living God, you give life and desire a future for all your children. Take hold of our nation, state and community and awaken in every heart awe for the gift of life. Send your Spirit to strengthen us with wisdom and fortitude as we defend mothers and children in Florida from laws that disregard their health and safety.

Mary and Joseph trusted in you and welcomed Jesus into our broken world. God Almighty, we ask their intercession to protect the preborn and their mothers, and to guide all parents in raising their children. May they help us build a civilization of love by upholding the sacredness of life and accompanying pregnant women in need.

We ask this through Christ, our Lord. Amen.

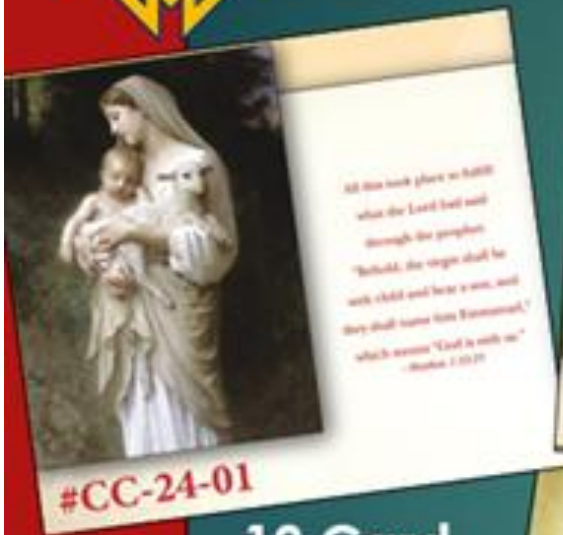
