### Message From Dea. Kevin Mukri

All Souls Day It is amazing to me the popularity of Halloween. Certainly, as a

child, I had a difficult time waiting the evening when I could dress up in a costume and go to my neighbors for candy. But now adults, long after their children have left their home, make a big deal of this day. Yet many of these same adults do not realize that Halloween is the evening before All Saints Day. They think of it as an evening to party and they forget that it is not about skeletons and goblins, but the evening before we honor all the saints, known and unknown.

Sometimes lost in the celebration of Halloween is the important date, November 2, which commemoration of all the faithful departed, who are saved, but await their purification to be completed in Purgatory before they are spotless and can enter into heaven. These souls, called the Church Suffering, can and do pray for us that we too may be saved. However, they can do nothing to hasten their purification in Purgatory, but we can and should help them. All Souls Day is important as the Church focuses her attention on the need of these poor souls for our assistants to pray for God's mercy for them and to bring them to paradise forever.

Our Blessed Mother told the three children of Fatima that the vast majority of souls that are saved must complete their purification in Purgatory. If fact Lucy asked the Blessed Mother if her cousin who died in her teens was saved, and Blessed Mary said "yes," she was saved, but she would be purified in Purgatory till the end of time. The Florida Fourth Degree will continue a Thanksgiving Weekend tradition by holding an Exemplification in the Orlando area at a new location:

Resurrection Catholic Church, 1211 Winter Garden Vineland Road, Winter Garden, FL.

The ceremony will begin a<u>t</u> noon on Saturday, Nov. 25. The event also includes a banquet following the ceremony; Vigil Mass; Ladies' Tea; and Patriotic Rosary.

Registration begins at 9:30 a.m., with Mass at 10 a.m. There will be the recitation of the Patriotic Rosary in the anteroom to get candidates into the proper frame of mind for the Patriotic Degree. The Exemplification begins at noon. There will also be a

Ladies Tea at noon.

The Exemplification will be followed by a banquet at 3 p.m.

The event honoree is SK Robert S. Urrutia of Davenport, the Immediate Past State Deputy, and a member of the Florida Exemplification Team.

Please note the dress code for the exemplification. While tuxedos are no longer mandatory, candidates must wear a dark suit (not brown!) and black dress shoes. Candidates are encouraged to write the number of their new assembly on the back of their KofC membership card.

Everyone is invited to support our Candidates and Honoree by purchasing an ad in the Exemplification program. <u>The cost of</u> <u>a full-page ad is only \$250</u>, and will include your Assembly or Council name, number, current officers, and your message. We will have pre-made pages for your convenience. <u>Half-page ads cost \$150</u>.
