
#### Prayer for the Canonization of Blessed Michael J. McGivney

# **Knights On Mission**

he 142nd Annual Meeting of the Supreme Council was held in Quebec City earlier this month, and a very successful meeting it was. The theme of the Convention was "On Mission". In his address to the Delegates, the Supreme Knight quoted St John Henry Newman, saying that ". . . every great change is effected by the few, not the many; by the resolute, undaunted, zealous few."

The Supreme Knight said that is what we must be: resolute, undaunted, and zealous in advancing our mission in today's world. There is no greater task of ours than to build up families, parishes, and communities that are centered on Christ. We are Knights of the Eucharist, and we are On Mission!

The Supreme Knight covered many works and initiatives the Order has accomplished this year. Of particular note, in preparation for the Church's Jubilee Year in 2025, the Order will be assisting with the restoration of baldacchino—the massive bronze canopy that rises above the papal altar above St Peter's tomb in St Peter's Basilica in the Vatican, as well as a bronze sculpture at the altar of the Chair of St Peter. The Supreme Knight also reviewed the humanitarian efforts the Order has done in Ukraine, aiding persecuted Christians, assisting with Disaster Relief, and many other works worldwide. All of us should be proud of what the Order stands for, and what we are able to accomplish as a unified Order!

I strongly encourage each of you to read the Supreme Knights address, as well as other materials about the Supreme Convention, available on the Supreme website.

The Supreme Knight also announced a new pilgrim icon program, to replace the St Joseph icons currently in circulation. This year is the 350th anniversary of St. Margaret Mary Alacoque receiving her visions of the Sacred Heart of Jesus in 1674, and Pope Francis, has announced that he's writing a new document — a reflection on the Sacred Heart — that will be released probably in

September. Therefore, in early 2025, the Order will help spread devotion to the Sacred Heart with the launch of a new pilgrim icon of the Sacred Heart of Jesus. We will not be able to schedule anything in Florida until we get more details, but Councils can and should tell their parishes pastors and about this forthcoming opportunity and seek their

support in hosting this new pilgrim icon.

Finally, as I have mentioned before in this publication and other forums, the vote on the proposed Amendment 4 to the State of Florida constitution is a very grave matter that all of us should be concerned about. The Bishops of Florida are unanimously opposed to this amendment, and many of them have posted video messages on Diocesan websites. I once again strongly encourage all Councils in Florida to engage with their parishes and Diocesan Life Committees and support the efforts to educate and help foster opposition to the amendment. While we cannot reasonably expect to have a mass conversion to the pro-life point of view, we can help to spread the word about the flaws in the language of this proposed amendment, and we can strongly help encourage our like-minded fellow Catholics to vote "no" on this proposed amendment in November.

an inspiration to remain strong in our ideals. The work of our Order, near and far, has never been more relevant to a world in need of inspired, faithful leaders. New initiatives and existing missions bolstered by needs unfolding in society will put Knights on mission more than ever.

# Rescue Mission Members Honored



hree members of the helicopter crew that played a role in a series of daring rescues earlier this year in Haiti were honored at the banquet following the July 27 Fourth Degree Exemplification at St. Gabriel in Pompano Beach.

Pilot Anthony Marinello, Co-Pilot SK Deacon Benny Matos and Flight Engineer SK Richard Sills were recognized at the ceremony, and each gave stirring recollections of the rescue. Sills had taken his Fourth Degree at the Exemplification, while Marinello missed the opportunity due to a conflict.

Marinello and Sills are members of John A. Hill Council 4955 of Pompano Beach, while Deacon Matos is a KofC Field Agent. They were joined at the banquet by State Haitian Development Coordinator Willie C. Gabriel Sr.

The presentation followed personal recollections of a trip one week prior to the Exemplification to the Honduras by Supreme Director Scott O'Connor and Florida District Master John O'Toole. The pair accompanied Msgr. Thomas Skindeleski in a follow-up visit to continue work on hurricane damage. The trio visited the country the previous year to help get a badly damaged school back in operation, while giving the local residents their first opportunity to celebrate Mass in over a year.

Marinello, of Fort Lauderdale, received a call from the office of Congressman Cory Mills of Volusia County on Sunday, March 10, asking him to take part in a rescue mission. He then called Deacon Matos, West Palm Beach, who had just participated in a Fourth Degree Exemplification at St. Frances Cabrini in Parish. They flew into a war

zone in Haiti to rescue 10 Americans at the Have Faith Haiti Mission & Orphanage in Port-au-Prince, including noted author Mitch Albom, who had established the orphanage in 2010 following a major earthquake devastated the capital.

Within hours of receiving the call, Marinello and Matos were in the air, making their way to the Dominican Republic while making multiple fuel stops. They waited until dark before flying into Haiti. Maneuvering their way through mountains into the city overrun by heavily armed gangs controlling 80-percent of the capital, arriving at 2:20 a.m. Finally, they saw a house with blinking lights – a prearranged signal – and Marinello hit the landing zone without taking a reconnaissance loop. Once on the ground, Mills quickly got the group onto the helicopter, and Marinello was back in the air a mere 67 seconds later.

After completing their unauthorized mission, the group encountered some political resistance back in the Dominican Republic, where the 10 rescued personnel were freed following the evacuation. Marinello got to shake hands with Album, not familiar with the successful author/ Detroit Free Press columnist whose work include Tuesdays with Morrie, The Five People You Meet in Heaven, Finding Chika (which is based in his orphanage) and the Little Liar.

The rescue had unintended consequences. Shortly afterwards – thinking Haiti was under invasion by the U.S. – Haitian Prime Minister Ariel Henry announced his resignation.

Marinello and Matos followed by running an additional 30 missions in April in which they evacuated 143 of the approximately 700 people rescued from the capital. While Sills did not fly to Haiti, he was responsible for preparing the helicopter for each mission.

# Council Continues Long Standing Program

he brothers of council 14212, St. Katharine Drexel and its newly installed officers have vouched to continue a longstanding program. The Bread of Life Program has been operational for the last nine years, including during the pandemic.

The program benefits the needy of the community and their families. The process includes several steps and coordination daily to be successful. A council brother is charged on a rotating basis with stopping by a prearranged Publix store and pick up bread and pastries that are donated. He then returns

to the parish before 7:00 to help set up the tables with other brothers for the distribution of the goods. The program runs daily from 7:30 to 9:30 or, as the saying goes, until supplies last. Anyone in the community can take as much as they want, even for family members that cannot make it to the distribution.

The pictures show brother knights setting up the tables and the goods available and the announcement that appears regularly on the parish bulletin.

# Council Lines Up It's Ducks



nights from Our Lady of Hope Council 8086 worked to get their ducks in a row at a recent evening in the Parish Office in Port Orange, preparing more than 23,000 plastic ducks for its eighth annual Duck Derby.

The Duck Derby is a highlight of the Port Orange Family Days. On Sunday, Oct. 13, the ducks will be liberated in the Port Orange City Center Lake, and the four winning entries will be retrieved by the council's Knights in Kayaks.

The winning duck carries a \$1,000 prize, with \$500 for second, \$200 for third and \$100 for fourth. To date, the initiative has raised more than \$100,000, with funds benefiting the many Knights of Columbus charities supported by Council 8086. These include Coats for Kids, Vocations, Global Wheelchair Mission, Habitat for Humanity, Pregnancy Crisis Center and numerous parish and community youth programs.

Tim Mell, now a Council 8086 Trustee and Florida State Knight of the Year for 2021-22, continues to oversee the program since its inception, working with Grand Knight Ernie Jackson for the three-time Division 3 Florida State

Council of the Year.

Duck Derby began as a challenge by Florida State Council officials Lorenzo Rodriguez and Danny McIntyre to find new ways of raising funds and promoting membership. Knights sell ducks for \$5 – or six ducks for a \$25 Quack Pack – at civic events throughout the region in the months leading up to Family Days. The event annually raises more than \$17,000 in donations and sponsorships.

At our State Convention in May, we donated \$30,000 and because of our efforts, they received a bonus of \$7,500 from Supreme. Special Olympics have also created an annual award in honor of Pete Chiaravalle, former Special Olympics Chairmen, and the inaugural winner was Jeff Marquet from council Saint John the Baptist in Jacksonville. We should all congratulate Jeff and thank him for his amazing and incredible support.

All year long, I have had the opportunity to meet and talk with so many of the Special Olympic athletes. They are doing great things on and off the field. In many cases they are attending universities and starting businesses. Truly awesome athletes.

# **Amendment 4 Action Resources**

he year 2024 is an election year. In accordance with the Laws of the Order, Councils and individual Knights cannot be involved in partisan politics. Any individual, of course, may be involved in partisan politics as a matter of free will, but a person cannot represent himself as a Knight in such activities, nor can Councils as an organization. Even the appearance of involvement in partisan politics must be avoided. This is particularly true with regard to the promotion, endorsement, or opposition to candidates for office.

However, Councils and individual Knights can be involved in nonpartisan issue advocacy, and there is a very grave issue that will be on the ballot in Florida in November-namely, the proposed Amendment 4 to the Florida Constitution which will enshrine unregulated abortion and make Florida one of the most proabortion states in the nation. The amendment language is very problematic, using undefined terms like "healthcare provider", "patient health", and "viability", which will very likely lead to allowance of second and third trimester abortions and take physicians completely out of the picture. And the amendment, if passed, would jeopardize existing laws and prohibit new ones that protect the health and safety of women, and would eliminate parental consent for a minor to have an abortion—which would make abortion the only medical decision for which parents have no say.

The Florida Bishops have issued a strong joint statement against this proposed amendment, and all of us here should become familiar with their position. You can find this statement on the website of the Florida Conference of Catholic Bishops. On that website, you will also find a document that published by the Bishops that explains why Floridians should vote "No" on this proposed amendment in November. Links to both of these documents can be found below.

As Knights of Columbus in Florida, our role as the Knights of Columbus is to do everything we can to support our Bishops and our clergy

in opposing this amendment. This is truly a lay evangelization mission, and we should take on this mission boldly and confidently, under the leadership of our Bishops.

First and foremost, our Bishops have asked us to pray, for without prayer, we will accomplish nothing. A specific prayer has been composed, which is available below. The State Deputy asks all Knights of Columbus Councils and Assemblies to recite this prayer at meetings and other gatherings, as a constant reminder of what is at stake.

Second, we must promote the reasons why this amendment is wrong. The Florida Conference of Catholic Bishops is publishing support materials for Dioceses and parishes to promote opposition to this amendment. We must stick to the messaging in these materials in our evangelization efforts to promote opposition to the amendment, particularly among our fellow Catholics, and not get creative with producing our own materials and messaging. Currently, other than the resolution passed at the State Convention, no Knights of Columbus messaging is authorized that is independent of the FCCB or Diocesan Respect Life Ministries.

Third, encourage all Knights—and all Catholics—to register to vote, and to vote "No" to this proposed amendment in November. Nonpartisan voter registration drives have always been a proper Knights of Columbus function.

Finally, Councils may want to donate money to help fund the opposition to this effort. The preferred way for a Council to donate money would be to the Diocese to which the Council belongs. If that is not possible, it is permissible to donate to the FCCB or other 501(c)(4) organizations that are promoting opposition to Amendment 4. However, extreme care must be taken so that Councils do not lose their tax-exempt status. A letter template that should accompany any Council donation to a 501(c)(4) organization is at a link below. We very strongly recommend that Councils do not donate to 501(c) (4) organizations not specifically recommended

by the Florida Conference of Catholic Bishops, and that Councils do not sacrifice their charitable contributions for donations to these organizations. Individuals may, of course, donate as they seem fit, but such donations will not be tax-deductible.

Councils may want to donate funds to help oppose Amendment 4. The preferred way for a Council to contribute is to the FCCB-approved 501(c)(4) organization promoting opposition to Amendment 4.

### **VOTE NO on 4 Presentation**



embers and guests of Notre Dame Council 10514 in Flagler Beach attended an informative presentation on the proposed Amendment 4 to the Florida State Constitution. The presentation was conducted by the Life Director in the Office of Human Life & Dignity in the Diocese of St. Augustine, Maureen Shilkunas.

Life Director Shilkunas pointed out that the extreme consequences should the amendment pass this fall. She read the actual wording of Amendment 4 and pointed out the following extreme measures that would be implemented should the amendment pass. She specifically highlighted three of the areas that would affect current Florida State abortions:

(1) No Medical Doctor Needed – the amendment would allow any health care provider to approve an abortion. The term health care

provider is loosely defined in Florida State law. It could be almost anyone from a nurse, dentist, or abortion provider staff member. Current Florida State law requires two medical doctors to approve an abortion.

- (2) No Parental Consent the amendment would remove the requirement of parental consent for an abortion that would be performed on their child. The language would be changed to only require parental notification. A cell phone text message could satisfy that requirement.
- (3) No Limit or Timeline on When an Abortion Can Take Place the amendment would nullify the recently enacted 'Heartbeat Protection Act'. Current Florida State Law prohibits an abortion after an unborn child's heartbeat can be detected. This is typically around the sixth week of pregnancy (there are exceptions for rape, incest, and to save the life of the mother). Should Amendment 4 pass,

abortion would be allowed through all 9 months of pregnancy with no protections for the unborn child.

Maureen stated that the Florida State Conference of Catholic Bishops has issued a pastoral letter opposing extreme Amendment 4. The Florida Catholic Bishops have formally launched its multilingual campaign to defeat Amendment 4 on the upcoming November ballot. They have launched a new website with a video entitled "Not What it Seems". The video exposes the deceptive nature and extreme ramifications of Amendment 4. She encouraged everyone to visit the website and view the posted video. It can be found at: https://votenoon4florida.com/

At the conclusion of the presentation, Life Director Shilkunas asked everyone to get involved with defeating Amendment 4. She asked attendees to speak to their friends, family, and neighbors and let them know the extreme consequences of the passage of Amendment 4. Most importantly she asked persons of faith to pray to our Blessed Mother for her intercession and to the Holy Spirit for the guidance to defeat this constitutional amendment.

#### Florida Bishops Oppose Extreme Abortion Amendment Vote No on Amendment 4

Florida Amendment 4, which will appear on Florida's November 2024 ballot, is an extreme proposal that legalizes fullterm abortion with no protections for the preborn child, including when the child is capable of feeling pain. This proposed amendment to our state constitution would prohibit all restrictions on abortion before viability and create a broad exception that any healthcare provider could exploit to allow abortion up to birth.

Furthermore, the amendment would effectively overturn or seriously jeopardize common-sense state laws that have regulated abortion for years. These include basic health and safety requirements for clinics where abortions are performed, requiring a physician to perform abortions, informed consent requirements, laws limiting public funding of abortion, and parental consent requirements before a minor's abortion. These risks demonstrate the extreme nature of the amendment.

We urge all Floridians of goodwill to stand against the legalization of late-term abortion and oppose the abortion amendment. In doing so, we will not only protect the weakest, most innocent, and defenseless of human life among us but also countless women throughout the state from the harms of abortion.

Human life is sacred. The dignity of the human person is the foundation of a moral vision of society. Direct attacks on innocent persons are never morally acceptable, at any stage or in any condition. In our state, human life is repeatedly being destroyed by abortion. Over 84,000 vulnerable and voiceless children were aborted in Florida in 2023.

This matter concerning the respect for human dignity and the fundamental value of human life is of grave importance to both our Church and our state. The threat of abortion remains our pre-eminent public policy priority. Therefore, we support a coordinated campaign to mobilize against the proposed amendment. To this end, we offer this prayer to defeat Amendment 4:

Ever-living God, you give life and desire a future for all your children. Take hold of our nation, state and community and awaken in every heart awe for the gift of life. Send your Spirit to strengthen us with wisdom and fortitude as we defend mothers and children in Florida from laws that disregard their health and safety.

Mary and Joseph trusted in you and welcomed Jesus into our broken world. God Almighty, we ask their intercession to protect the preborn and their mothers, and to guide all parents in raising their children. May they help us build a civilization of love by upholding the sacredness of life and accompanying pregnant women in need.

We ask this through Christ, our Lord. Amen.

# Obispos de la Florida se Oponen a la Enmienda Extrema sobre el Aborto Voten No en la Enmienda 4

La Enmienda 4 de la Florida, que aparecerá en la papeleta electoral de la Florida en noviembre de 2024, es una propuesta extrema que legaliza el aborto a término sin ninguna protección para el niño antes de nacer, incluso cuando el niño es capaz de sentir dolor. # OFFICE OF YOUTH PROTECTION SAFE ENVIRONMENT PROGRAM (SEP)

#### KOFC.ORG/SAFE

Under Faith in Action, certain state and council officers/directors are required to complete the Order's safe environment training and may also be required to provide authorization for a background check.

If members in certain roles are not compliant within 30 days of notification, they are subject to removal from those roles.

Email addresses are required when completing the Service Program Personnel Report (#365) for the program, community, and family director roles. Praesidium, the Order's safe environment partner, will email grand knights, program, family, and community directors assigned usernames and passwords to complete the training. They will also email family and community directors a personalized link to provide background check authorization. The Knights of Columbus covers all costs associated with these

requirements. Although the grand knight may also hold one of the following roles, there must be three (3) different members assigned to the program, family, and community director roles.

Email notifications are unique to each recipient and cannot be forwarded or used by any other member. The time-sensitive notifications require the recipient to complete training and background check authorization within 30 days of receipt.

All members who have access to Officers Online may view the safe environment status of their council or jurisdiction each week on the Reports tab.

For a council to be compliant with the safe environment program, all SEP roles must be filled and compliant. If the council sponsors a Columbian Squire Circle, the circle must also be fully compliant.

# Safe Environment Program Council Compliance Guide (Rev 5/10/2024)

The following criteria must be met for a council to be Safe Environment compliant:

- 1) Email addresses are mandatory to appoint members into ALL roles that have safe environment requirements. Emails must be unique to the member, NOT gkcouncil123@XYZ.com to ensure that members retain credit for completing their training and background checks.
- 2) There must be a Grand Knight assigned via Form 185 through Member Management.
- 3) The council must have submitted Form 365 Report of Program Personnel or named program personnel via online Member Management. Watch this video to learn how to submit online: https://players.brightcove.net/802593642001/y6FLila0f\_default/index.html?videoId=6191938577001
- 4) On the 365 Report, there must be **three different members** assigned to:
  - a. Program Director
  - b. Community Director
  - c. Family Director
    - \*Grand Knights may only hold **one** of the additional director roles listed above.
- 5) All roles above must complete the Safe Environment training. The **Community Director** and the **Family Director** must also provide consent for a background screening (criminal and motor vehicle records).
- 6) If the council sponsors a Squires Circle, that circle must be compliant for the council to be compliant. The following criteria need to be met for the circle to be compliant:
  - a. Form 468 must be submitted appointing counselors every year
  - b. One (1) Chief Counselor must be appointed
  - c. A minimum of one (1) Adult Counselor must be appointed
  - d. The circle must have a minimum of ten (10) Squires
  - e. For every additional ten (10) squires, there must be one (1) additional Adult Counselor
    - i. Example 1: 10-20 Squires must have 1 Chief Counselor + 1 Adult Counselor
    - ii. Example 2: 21-30 Squires must have 1 Chief Counselor + 2 Adult Counselors
    - iii. Example 3: 31-40 Squires must have 1 Chief Counselor + 3 Adult Counselors ...et cetera
  - f. Chief Counselor and Adult Counselor(s) must complete training and provide consent to a background screening.
