

## Knights On Bikes Convention



orty-five bikers from throughout the state of Florida rode into Leesburg on April 14-16 for the Knights on Bikes Florida Annual Convocation.

Our Lady of Mt. Carmel Council 13300 of St. Vincent de Paul Catholic Church in Wildwood hosted the event, led by incoming Grand Knight Mike Lepore. State Deputy SK Rob Urrutia was a special guest at the convocation.

The Knights met for a weekend of fellowship, riding, smoking cigars and a few meetings.

George Gutierrez, representing St. John XXIII Council 14390 of Miramar, was named new Knights on Bikes Florida President. Other officers announced at the Convocation included:

The Knights took advantage of the winding roads in the Leesburg area for several rides. On Friday the early arrivals rode for 45-miles on farm roads, highlighted by a stop at Mystic Ice Cream in Fruitland Park for delicious homemade ice cream. Saturday afternoon's 75-mile ride included a stop at the Florida National Cemetery in Bushnell, where they stopped for a rosary and a few cigars.

"We got drenched on both days on the ride back," said SK Lepore. "Fortunately, Father McGivney kept us safe."

"It was a lot of fun, spending time with my Brother Knights from all over the state," said State Secretary-Treasurer SK David Campos from Miami Lakes. "Our State Chaplain Father Bob [Kantor] calls us a 'moving billboard,' because we ride in packs with our bright yellow vests with the big KofC logo on the back."

A personal highlight for Campos was the installation of his son Ryan into the Knights on Bikes. Ryan is a 21-year-old student at the

University of Florida and member of the college council.

"I am humbled and honored to have been elected as your new State Vice President," said SK Knapik. "It was a privilege to be your Orlando Diocese Chairman for the last couple of years," and I am very excited to pass the torch to Brother Miles Brookes! Please give





him all of the same support that you gave me during my time as Diocese Chairman. Also, thanks to Worthy outgoing President Stephen Bell for all of his leadership and service over the last several years as President. And thanks to Worthy outgoing State Vice President George Lopez for all of your service and efforts as well!" The Knights on Bikes Florida's big event is the Ride for Vocations on May 25, followed by the Florida KofC State Convention in Orlando on May 26-28.

The Knights on Bikes Florida are already making places for next year's Convocation, set for Panama City on April 26-28.

Prince of Peace Council 8791 of Ormond Beach recently held its sixth blood drive of the Fraternal Year, with a four-and-a-half hour visit by the Big Red Bus.

Giving blood with "One Blood" is safe and controlled and includes a Wellness Checkup. One Blood also offered a \$20 eGift Card and a short sleeve "Giving Your Best Life" T-Shirt in April in response to the critical need for blood in our area.

During the last Fraternal Year, Council 8791 gave 86 pints of blood as part of its "Faith in Action" Program. This year's goal is 100 pints. The Council started off this Fraternal Year "with a bang" in July contributing 16 pints of blood, followed up in September with 15 pints which was awesome, and hitting it out of the park in October with a whopping 18 pints. In January, the total was 26 pints of blood, the single greatest contribution in one day in the Council's history (as far as we know) and in March donated another 18 pints. This was a total of 93 pints

donated for the Fraternal Year leading up to the April visit.

"I have chosen you out of the world." ~John 15:19 (Gospel for May 13: Our Lady of Fatima)

or Catholics, May evokes happy memories of First Communions, May Crownings and the celebration of Our Lady of Fatima. It is Mary's month as well as the month in which we honor our mothers. It fed my spirit, and the time behind the wheel became a welcome respite from the busyness of life. Ultimately, the prayer time led me closer to Christ in the priesthood.

You don't have to be called to a religious

vocation to enjoy the fruit of Mary's intercession through the Rosary. Try it yourself, if only a decade at a time, during your drives, or as you walk from the car to your destinations, whether they be offices, stores, restaurants, or church. The rosary's repetition can calm our spirits. After a while, praying it is as natural as breathing.

## The Beginning of a New Life

hen we look at the Old Testament, we see God gathering a people unto Himself through Abraham and then teaching them how to follow Him through Moses and the Ten Commandments given to him by God.

In the New Testament, we see God fulfilling His Promise to Adam and Eve of a Messiah. That Messiah, who was born of a Virgin and named Jesus, fulfilled that Promise of salvation to Adam and Eve and to the world by His Passion and Death. In the Resurrection of Jesus, as described in the New Testament, Jesus opened the Gates of Heaven to us and a "new way of life" in order to reach eternal life.

There are two events that we celebrate in May that describe the foundation of that new life. The first is the Ascension of Jesus. Jesus ascends to the Right Hand of His Father and sits in Power with Him. As he ascends into Heaven, He says to His Apostles, "Go teach all nations." Thus, He now lays the foundation of this "new life." In laying down this foundation, He also tells His Apostles that, "I am with you all days until the end of the world." He lays down with this Promise of being with them a trust in His Apostles, that Jesus will continue to be the foundation and support for them in this "new life" that they will develop.

The second event we celebrate in May is Pentecost. We call this the birthday of the Church because, by the descent of the Holy Spirit, the Apostles received complete knowledge of Jesus, His mission, and their mission.

The Apostles went out to evangelize the people of God after Pentecost, baptizing them into the body of Christ, and building up a worshipping Church community. The centerpiece of the Church community they began to build, as chronicled in the Epistles, was the Eucharist, the Pearl and Crown of the Church of Jesus Christ, and the body of Christ.

We are the inheritors of this rich history of salvation and the founding of the Church. That ministry of founding and leaving the Church has been a continuing process for over two thousand years and is our "new life." You and I are in the middle of this ministry and "new life" today, and Jesus says to us, "Go teach all Nations". The Holy

Spirit, given to the Apostles at Pentecost, has been given to us in baptism. As the Apostles, the Holy Spirit was given to them and us as a Divine Guide who protects and guides us in our ministry. Let us accept this gift of the Holy Spirit and baptismal mission of living this "new life" in the Church with joy, energy, determination and commitment.



## Relics of St. Faustyna

orpus Christi Assembly 2810 in Flagler Beach celebrated Divine Mercy Sunday with a presentation entitled "Messages of Divine Mercy: A Program with Relics of St. Faustyna," at Santa Maria del Mar Church.

This first in Florida program was presented by the Apostolate for Holy Relics, which featured Exposition of the Blessed Sacrament, recitation of the Divine Mercy Chaplet, accompanying music, meditations from St. Faustyna's Diary and veneration of holy relics.

Denise Serafini, Event Coordinator, gave a brief history of St. Faustyna Kowalska prior to beginning the program. The saint was born in Poland in 1905. She was the third of 10 children. She felt strong stirrings of a religious vocation at an early age. She later entered the Congregation of the Sisters of Our Lady of Mercy in 1925. She was privileged to be visited by Jesus Himself. Jesus made it known to her that he wanted her to tell the world of His 'unfathomable' Mercy.

Sr. Faustyna was instructed to write these interactions down. They were recorded in a diary that she titled "Divine Mercy in My Soul". The Diary has been translated into more than 20 languages. On April 18, 1993 Pope John Paul II raised St. Faustina to the glory of the altar.

The program began with reflections from St. Faustyna's Diary. Event Coordinator, Denise Serafini, read dialogue from the diary as the voice of St. Faustyna. Fr. Manny Lopez, Pastor and Assembly Faithful Friar, read the dialogue of Jesus.

Father Lopez, assisted by Deacon Stephen, opened the tabernacle and brought the host to the Monstrance for Exposition of the Blessed Sacrament. Those in attendance prayed reverently to Jesus, truly present on the altar. A short time later, PFN Bryant Perszyk led the faithful in the praying of the Divine Mercy Chaplet.

The more than 200 attendees were invited to venerate the religious relics present. The Relics of

- A piece of the True Cross which was discovered by St. Helena
- A 2x4" piece of St. Faustyna's veil
- A piece of St. Faustyna's veil with bone imbedded
- Various materials used by St. Faustyna

## Council Contributes to Miracle League




ather Downey Council 4934 of New Smyrna Beach recently donated \$2,000 in its continued effort to support the Miracle League of Volusia County.

Grand Knight Leo Decker was joined by a dozen Brother Knights and spouses from the Sacred Heart Catholic Church-based council at the ceremony.

"They have two teams in a disabled children's league, aged up to around 40," Decker said. "Parents get to see their children enjoying baseball and other various activities. Volunteers and parents assist the children hitting the ball and running the bases. This project has been very well received by our Knights and families."

The Miracle League of Volusia County was formed in 2015 as a non-profit 501c3 corporation giving those with special needs an opportunity to play America's favorite pastime. To further its goal of serving more than 13,000 school-aged children with varying exceptionalities in Volusia and Flagler counties, they built a \$250,000 rubberized baseball field that accommodates wheelchairs and walkers, as well as other assistive devices. The property, provided by the City of New Smyrna Beach, is located in the New Smyrna Beach Sports Complex on Turnbull Bay Road.

Christ Our Redeemer (COR) hosted the 42nd Annual Liturgical Celebration Commemorating Black History Month and the Archbishop of Washington D.C., Wilton Cardinal Gregory concelebrated Mass with Bishop William A Wack, Bishop of Pensacola-Tallahassee, and Fr. Bob Johnson, pastor.

This event is organized by The Catholic African American Cultural Awareness Group of Okaloosa County. The first celebration took place in 1982 at Holy Name of Jesus Church in Niceville but moved to St Mary's Church in Ft Walton Beach due to growing attendance. Last year, the celebration returned to Niceville at Christ Our Redeemer which can seat 600 comfortably. Over 300 people attended the Mass and we're over 350 views on the Facebook livestream.

The celebration began with a concert by the Eglin AFB Brotherhood Gospel Choir followed

by a Liturgical dance by the Annointed Angels of Grace Praise Dancers. Then, probably the most elaborate entrance procession you'll ever see in Niceville began the Liturgy. A joint Honor Guard of the Knights of Columbus (Assembly 3236) and Knights of Peter Claver (Assemblies 1&52), who wear traditional regalia, led off, followed by numerous Altar Servers, Deacons, Priests, Bishop Wack and Cardinal Gregory. Their Supreme Comptroller and past Supreme Knight also attended. After Mass, the parish hall was filled with people enjoying a complimentary dinner arranged by the organizers.

To assist the many visitors, COR Council 13527 directed parking, unfortunately in the rain. Although the two Knight honor guard organizations do things somewhat differently, they managed to blend in seamlessly. Like Jesus prayed, "that all my followers be one."

## Habitat for Humanity Partnership



his month's project was managed by Brother Knight Michael Mahan, Habitat for Humanity Chairman. This represented the 4th Habitat project in 2023 and cumulatively the 76th monthly project in a row since January 2017.

On Thursday, April 27th, 2023, 9 Knights of Saints Cosmas & Damian Council #13341 responded to the triangle property across the street from the Habitat Depot in Palmetto and assisted with landscaping at two of the four homes currently under construction.

The project team completed the following tasks:

- 1. Planted two (2) trees (one tree per front yard).
- 2. Installed black plastic landscaping edging to form front yard shrub beds at each house.
- 3. Installed black fiber weed screening in each shrub bed.
- 4. Planted approximately three dozen assorted bushes/ shrubs in shrub beds.
- 5. Wheelbarrowed mulch from opposite end of construction site and installed same in shrub beds after completing plantings.

- 6. Raked and graded both front yards to prepare for sod planting at a future date.
- 7. Installed post office box posts at both houses.
- 8. Placed two (2) yards of crushed shell around the outside perimeter of one of the houses.

Cleaned up all construction debris at both homesites. Discarded same in Depot dumpster. Cleaned and stored all garden tools and equipment in Depot



## Star Council Award

he Star Council Award recognizes outstanding achievement in membership, insurance and programming. In order to achieve the Star Council Award, a council must earn the Father McGivney, Founders', and Columbian Awards. Additionally, the council must submit both the Annual Survey of Fraternal Activity (#1728) and Service Program Personnel Report (#365). In the United States and Canada councils must also be fully compliant with applicable safe environment requirements.

Prior to the end of the fraternal year on June 30, make sure that your council achieves the requirements to qualify for your awards. To view your quota and/or progress towards earning the Star Council Award, please log on to Officers Online regularly.

#### **COLUMBIAN AWARD**

This award recognizes excellence in your council's programming and charitable outreach. To earn this award your council must conduct and report programs in each of the four program categories (Faith, Family, Community, and Life) for a total of 16 program credits, with four in each category. A completed Columbian Award Application (#SP-7) must be received by the Supreme Council office by June 30 in order to earn this award.

Virtual/remote programs will be counted in the same manner that they would have been if conducted completely in person. Please note that hybrid events should only be counted once (not as both an in person AND virtual/remote event).

There are no required programs.

#### **Featured Programs**

The Supreme Council has designated certain programs as featured programs in each of the program categories. When your council conducts a featured program and satisfies the associated requirements it will receive two credits towards that program category on their <u>Columbian Award Application</u> (#SP-7). The featured programs for

each category are listed below.

**Faith** - Refund Support Vocation Program (RSVP), Holy Hour, Spiritual Reflection, Into the Breach.

**Family** - Food for Families, Family of the Month, Family Prayer Night, Family Fully Alive

**Community** - <u>Coats for Kids</u>, <u>Habitat for Humanity</u>, <u>Global Wheelchair Mission</u>

Life - March for Life, Special Olympics, Ultrasound, Pregnancy Center Support (includes Aid and Support After Pregnancy – ASAP)

#### FATHER MCGIVNEY AWARD

This award recognizes excellence in your council's membership growth. To earn this award your council must meet or exceed its yearly membership quota. The council quota for 2022-2023 is 6% increase in the council's membership as of July 1 (minimum of five and maximum of fifteen). There is no application for the Father McGivney Award.

Councils that attain Star Council status and achieve 200 percent of their gain goal will receive the Double Star Council Award. Councils that achieve 300 percent of their gain goal will receive the Triple Star Council Award.

All membership transactions must be received, processed, recorded, and released at the Supreme Council office by June 30.

#### FOUNDERS' AWARD

The Founders' Award recognizes excellence in the promotion of our insurance and fraternal benefits. Councils striving for the Founders' Award must host (or co-host) two fraternal benefit seminars (in-person or virtual) per year. Each council must have a minimum of 7 members or member-eligible attendees at each seminar. These events are coordinated in conjunction with your local field agent. In order for the council to receive credit, the grand knight must submit the <a href="Fraternal Benefit Seminar Form">Fraternal Benefit Seminar Form</a> (#11077) to the general agent within seven days of the seminar.

## Columbian Award Application

any councils are now, or soon will be, completing the Form SP-7 Columbian Award Application in recognition of their fraternal programs conducted between July 1, 2022, and June 30, 2023.

The deadline for submission of the SP-7 is June 30, but councils are strongly encouraged to submit the SP-7 early, as soon as they complete four program credits in each category of Faith, Family, Community, and Life. This article provides additional information to assist councils with successful submission of the SP-7.

The following answers were provided in an April 24, 2023, email from Tyler Lomnitzer, Senior Director, Programs and Member Engagement at Supreme Council:

"How can a council tell if the SP7 is indeed accepted and not rejected later?

If we receive the application prior to June 1 we will send the GK an email letting him know if the application was approved or rejected. Due to the high volume of submissions after June 1, we do not send emails to GKs. The Star Trackers and Awards Progress Reports provided to RGDs would be the next best option to determine council status."

"Can you tell me, if a completed form is submitted and "not accepted", how do they know the reason?

We do not have the manpower to explain the specific reason(s) why an application was rejected. Usually, it is because the council did not report enough program credits or they listed a "procedural Church activity" as a program (i.e.. Attended Funeral for Brother Knight). A council can always email fraternalmission@kofc.org and we will provide a specific reason."

"Also, once it is accepted, is that all they need to be concerned with?

Once the application is approved, that is all a council needs to be concerned with as far as the Columbian Award is concerned. There are of course additional requirements for Star Council."

Note: GK is Grand Knight, RGD is Regional Growth Director

Additionally, here is a question and answer regarding submission of revised or corrected SP-7s:

"...the system is blocking councils from submitting revised, corrected SP-7's, giving them the message that the form has already been submitted. They ask if we were aware of this and knew of a workaround.

Yes, we are aware of this. Unfortunately resubmissions will have to be done via PDF and emailed to FraternalMission@kofc.org.

Finally, as indicated in the Faith in Action Reference Guide #1172, the Grand Knight is the one who submits the online SP-7 to Supreme Council.
