Grand Knight Guy Scavelli had arranged for the council to go out to SHP's Bunks Across America event on Saturday, September 14, 2024, in West Palm Beach, FL, where seven of our brothers helped build fifty beds for the community's most needy families. The local volunteer staff of SHP was kind enough to take everyone through

the process, from unloading and cutting lumber, sanding the wood, pre-drilling holes and screwing the varied components together for final assembly.

Once finished, all the components are delivered throughout Palm Beach County to families in need who have been identified by SHP. The end-product is a sturdy and comfortable bed, with mattresses provided by local and national sponsors, ensuring a safe bed for children in need.

any of us grew up in the north when this month of October ushered in dramatic changes in nature. Still others will pray Rosaries for intentions like an end to the death penalty, reflecting the consistent life ethic of our Church.

One of the primary things we can do to respect life rests in the way we treat others, even those with whom we disagree. It's hard to have credibility in standing up for life when we destroy the one to whom we're communicating. Small acts of kindness and lifting others up can help us see the good in our neighbor and overcome differences to be united more closely in the One who made us all.

As we are a quarter of the way through our fraternal year, this month also offers us a reminder to invite other Catholic men to the life-giving experience of being a Knight of Columbus. As members of this order, we must also care for the lives of our brother Knights and their families, especially those who are alone or

Questions for Reflection:

When you give of yourself — whether of your financial resources or your time — do you give only from your abundance? What might you be able to sacrifice in order to provide more assistance to those in need? Are there any specific actions you could take to give more to others?

The Mass is held to recognize all first responders, active or retired, in Eastern Volusia County. Its purpose is to publicly recognize their diligent work in protecting the Our Lady of Hope parish community and the region, to thank them for their service and pray for their continued safety and success.

Among the agencies in attendance were Sheriff Mike Chitwood and the Volusia County Sheriff's Department; Port Orange Police Department Color Guard; Port Orange Fire Department. Public Safety Volusia County; and the Volusia County Sheriff's Emergency Management, Bomb Squad and Marine Unit.

The first responders gathered in the Father Raymond O'Leary Parish Center. Then, the Fourth Degree Assembly 2794 Color Corps led the procession into the church, followed by the Port Orange Police Department color guard and the first responders.

In addition, the Volusia County Sheriff Bomb Squad, Volusia County SWAT, and the Volusia County Sherriff's Marine Unit loaned emergency vehicles and water craft to be put on display outside the parish social hall.

Following the Mass, the first responders were invited to the Parish Center to enjoy coffee and donuts as a thank you for their service and participation.

The Blue Mass is one of the many activities undertaken by the council. Activities include the Duck Derby, Casino Night to benefit Catholic Schools, Evening with the Knights to benefit the Ultrasound Initiative, Coats for Kids, Vocations, Global Wheelchair Mission, Habitat for Humanity, Pregnancy Crisis Center, Aid and Support After Pregnancy (ASAP), and numerous parish and community youth programs.

Silver Rose Prayer Service

n September 8th, 2024, the Knights of Suwannee River Council 9720 gathered to honor the Blessed Mother by celebrating the Silver Rose Prayer service at two Masses. In the presence of the Silver Rose, both the English and Spanish Masses at St. Francis Xavier Parish in Live Oak, Florida, led by Father Pablo Fuentes, took time to pray for peace and the end of abortion.

The Rose was transported to Live Oak from Holy Family Catholic Church in Williston, Florida by Daniel Noblin, the Council's District Deputy for District 8 and Michael Flowers, the District Warden and the Council's Grand Knight. The Knights of 9720 were especially thrilled to have the Silver Rose present on the 8th, as this is the date that the Feast of the Nativity of the Blessed Mother is traditionally celebrated.

Following the two Masses, the Knights of 9720 hosted a free meal, open to all parishioners in honor of the Blessed Mother and the presence of the Silver Rose in their parish, while on its pilgrimage. This meal was prepared by Brother Rene Yaxon, the council's newly appointed Spanish Roundtable Coordinator, with the assistance of several Knights and other members of the parish. There were between 100-150 people fed. According to the council's Grand Knight, Michael Flowers, Council 9720 is devoting this year to deepening its commitment to bringing the entire parish together and uniting the English and Spanish speaking communities through their shared faith and devotion.

The Grand Knight shared some of his thoughts with the Invocation. He reported, "We have an obligation as a Council, to be certain that our doors are opened for all our parishioners. The Spanish speaking community of our parish is full of deep and abiding faith, and our council wants to make sure they become active members of the Knights of Columbus. Most of the children in our parish's CCD program are from Spanish speaking families, the Spanish Mass normally has twice the number of attendees as the English-speaking

Mass immediately prior. Yet, these numbers are not reflected in our Council membership. We are working to correct that this year. With the assistance of my Deputy Grand Knight Leo Morin, of Cuban American decent and Rene Yaxon, a Guatemalan-American, we are attempting to build a bridge between the two communities. I can think of no greater bridge-builder than our Blessed Mother.

As Knights, our Lady of Guadalupe is our Patroness, and she is of course, revered amongst many Spanish-speaking cultures. Being able to bring people together on the Nativity of the Blessed Mother, made this day even more special. Council 9720 looks forward to hosting more events in the coming fraternal year to deepen the faith of our members and to build a bridge in our faith community. We hope many other councils in our jurisdiction will do the same. We share a common faith, and what unites us is always greater than anything that could divide us."

While Zipporah didn't make it into this world, she was loved by so many.

While Frank was unimaginably grieving with his family, he still took the time to reach out to the current Grand Knight of the Council, Selem Lake, to request the Fourth Degree Color Corps be present at his daughter's funeral at St Elizabeth Ann Seton Parish on Sept, 2.

On August 27, DD60 Jeff Vespo reached out to all Councils, Assemblies, DDs, RAs, and Vice Marshals in the SWFL area calling for a strong showing of Brother Knights and Color Corps to participate in the Funeral Mass. The response was staggering, as 29 Color Corps members from Naples to Cape Coral – including seven Color Corps Commanders – were in attendance to show their support and unity to the Roberts family.

As the family, the local council members, the Pastor, and the Parish staff came into the church,



all were stunned by the showing of the Color Corps of the Knights. Pastor Father Casey Jones – who had only become a Fourth Degree Knight in May – commented that he had never seen such a testament to brotherhood and unity as that display of the Color Corps at that Mass. He was very proud to have become a Sir Knight.

It was a heartbreaking day for all involved, but the support by so many Knights from so far away was a testament to the Fraternal bond that Knights have with each other and, to an even greater extent, how much the value of the life of a child means to all men of faith!

Serving Pinellas Hope



he Knights of St Paul's Parish in St Petersburg cooked and served 216 meals to the residents at Pinellas Hope on Thursday August 29th. Preparing the evening meal for Pinellas Hope has been a regular community service activities of this council for many years. The St Paul's Knights are just one of many groups that contribute to the outstanding service that Pinellas Hope provides to the homeless.

Pinellas Hope, a program of Catholic Charities Diocese of St. Petersburg opened on 10 acres of land provided by Bishop Robert N. Lynch and the Diocese of St. Petersburg. It was developed as a pilot program in December 2007 and continues to provide a comprehensive array of services and shelter to homeless individuals. Today, Pinellas Hope continues its mission of providing a safe living environment and the necessary support for homeless adults to become self-sufficient. Since its formation, Pinellas Hope has served over 10,000 people and served over 1.6 million meals.

Council Provide Ultrasound Machine

epresentatives from Notre Dame Council 10514 of Flagler Beach recently attended a reception at 'A Woman's Answer Medical Center (AWA)', a crisis pregnancy clinic in Gainesville.

FDD Kevin Ryan, and Past Grand Knights Michael Boullion and Bob Conochalla were there to celebrate the blessing of AWA's new ultrasound machine, a donation from the council through the partnership with the Supreme Council's Ultrasound Initiative Program. The new ultrasound machine replaces one that was 20 years old.

The new ultrasound machine was blessed by Father Ed Murphy, parochial vicar of Holy Faith Catholic Church. Maureen Shilkunas (Director of the Office of Human Life and Dignity for the Diocese of St. Augustine) led the attendees in thanksgiving for all of those that have dedicated their time and energies to saving babies.

Lunch was provided by the clinic's Board of Directors. In attendance were Lori Hiebert (Executive Director of the clinic), Filomena Smolenski (President of the Board), Michelle Kenlon (Board Vice President), Janet Schmittgen (Board Secretary). Other board members present included Angela Medyk, Belinda Herring, Maryanne Walker, Frank Kenlon, Jennifer Mullis, Joan Scott, and their spouses and family members.

The funds for the ultrasound machine were provided by an anonymous donor. The donor was a 'snowbird' attending Mass at Santa Maria del Mar Church in Flagler Beach. He was impressed with the many activities of the Notre Dame Council and how well the council and parish worked together. He learned of the Knights of Columbus pro-life programs and inquired as to what were the past and current pro-life programs of the council. Part of those discussions where the fact that the council was able to fundraise and assist in the placing of eight ultrasound machines in crisis pregnancy centers in the Diocese of St. Augustine since 2017. This led to a commitment to fund an ultrasound



machine purchase for 'A Women's Answer'.

Although this was the ninth ultrasound machine in which Council 10514 fundraised, it was the first one that utilized the Knights of Columbus Charitable Fund (KCCF). The donor stated he preferred to donate monies through a 'Qualified Charitable Distribution' (QCD) from his IRA. Kevin Ryan, PGK, serving as District Deputy, contacted the Supreme Council KCCF office about the process. The donated funds were able to be transferred directly into the council's KCCF pro-life fund. The necessary funds were later transferred to the Florida State Council's Charitable Fund after the completion all of the proper forms and final approval for the ultrasound machine. The Supreme Council then sent the matching funds for the ultrasound purchase.

AWA staff members pointed out that of the hundreds of ultrasounds they have performed, they have only lost one child to abortion after the mother viewed her ultrasound. They also expressed their gratitude to the Knights of Columbus for the new ultrasound machine. The donation of this very important life-saving equipment eliminated the prospect of diverting limited funds from other needs of the ministry or foregoing the availability of a machine to provide free ultrasounds for women.

Council Hosts The Silver Rose



he Knights of Columbus (KofC) have celebrated the Feast of Our Lady of Guadalupe for the past 60 years. This feast, which commemorates the miracle of the roses where Mary, our blessed mother, instructed St. Juan Diego to have a temple built in her honor at the base of Tepeyac Hill. She used the roses as her sign to the Bishop to ensure they knew the request was from her.

The KofC sponsor the silver rose's journey which lasts from February through December

and travels from Canada to Mexico with stops in several cities along the way. On August 4th, the parish of Mary, hosting the silver rose. In conjunction with members of the 4th Degree Assemblies of St Catherine of Siena Assembly 3154 and Father Edward Massey Assembly 2564, which provided the color corps, the event was attended by 62 parishioners and an additional 28 fellow knights. These were the largest turnouts the parish had ever experienced in the 4 years that they have hosted the silver rose service.





9-11 Memorial Ceremony



nights of Columbus Notre Dame Council # 10514 held a September 11th Remembrance Ceremony at Veteran's Park in honor of the almost 3,000 people killed in the September 11, 2001 terrorist attacks. Program Chairman and Master of Ceremonies for the event was Knights of Columbus Past Grand Knight and Former District Deputy, Kevin Ryan.

Former Air Force Military Chaplain, Fr. Ken Beale, gave the opening Benediction. Fr. Beale is a New York City native and related how he called his parents from this active-duty station in Utah on the morning of September 11th. They gave him a first-hand account of what could be clearly seen of the World Trade Center towers from their apartment balcony. He was on the phone with them when the second plane struck the second tower. He later led the attendees in the 'Prayer of St. Francis' and also offered the closing prayers for the ceremony.

Joseph DePalma was this year's guest speaker. On September 11th, he was called from his home in New Jersey to assist the First Responders in setting up lighting, ensuring electrical grids were safe, as well as working to seal off the labyrinth of plumbing lines. He also assisted in the removal of the bodies of the deceased at Ground Zero. He related how there was a sense of reverence that

took place as all of those present worked to look for survivors after the tragic event.

The Corpus Christi Assembly 2810 Fourth Degree Color Corp members served as honor guards for the ceremony. The Matanzas High School J.R.O.T.C. Color Guard posted the American Flag and the Florida State Flag at the event. Retired uniformed members of the New York City Police and Fire Departments were present along with a number of First Responders from the Flagler County area. Local dignitaries present included Flagler Beach Mayor Patti King, Commissioner Jane Mealy, and Police Chief Matthew Doughney. Program Chairman Ryan thanked the city officials for their continued support and assistance in setting up the annual event.

A special 'Blue Mass' was celebrated at Santa Maria del Mar Catholic Church by Fr. Ken Beale, assisted by Deacon Bob Krol, for all current and past members of the military, police officers, firefighters, and first responders.

She has been very instrumental in managing a program of over 60 athletes. Congratulations to both Chris and Elizabeth for an amazing year in 2024. Let us as councils from around the state continue our support and volunteer with Special Olympics.



An Honor of a Lifetime

ttending the 142nd Supreme Convention in Quebec as a Delegate from Florida was an honor and privilege of a lifetime. The 142nd Supreme Convention was a momentous event, marking a significant gathering of the Knights of Columbus. Delegates from various regions, including Florida, convened to celebrate their shared mission and values.

The convention was a vibrant tapestry of tradition and vision, with the opening Mass setting a reverent tone. The Supreme Knight's Annual Report was a focal point, highlighting the organization's growth and outreach

From the sea of white robed Clergy at the opening Mass, to the Supreme Knights Annual Report, to the States dinner, Award Session and the Memorial Mass, the message from Supreme was clear. We are all called to be a missionary, reflecting the goodness and love of God in Christ. This calling was reflected in inspirational speeches from such dignitaries as His Eminence Gerald Cyprien Cardinal Lacroix, Archbishop of Quebec, His Eminence Mauro Cardinal Gambetti, Archpriest of St. Peter's Basilica, His Eminence Sean Cardinal O'Malley, Archbishop of Boston and Most Reverand William E. Lori, Archbishop

of Baltimore.

The highlight of the Supreme Convention was the Supreme Knight, Patrick Kelly's Annual Report. Following a brief lesson on the history of the Catholic Church and its growth in Canada, announced that Devotion to Blessed Michael McGivney is growing. A marble stature of our Founder was dedicated in the Basilica of the National Shrine and this coming winter St. Patrick's Cathedral will unveil a statue of Father McGivney.

The growth of the Knights was highlighted by the Supreme Knight. Membership is now at 2.1 million men. This past year over 92,000 men joined our ranks. There are now more than 17,000 Councils worldwide – with exciting growth in Cuba and Mexico.

Along with growth comes a greater opportunity to give more. Last year, 47 million hours was spent on a mission, with over \$190 Million in charitable works. One million children's coats have been donated, the Global Wheelchair Mission has enabled 11,000 people to be mobile again, and more than \$4 million was donated to Special Olympics.

Promises have been kept, the Supreme Knight stated, to the more than 20 million Catholics of

Nigeria. The Knights will sponsor and fund the ongoing formation of priests and lay leaders. The Knights launched a program in the Philippines called "Guardians of Dignity," training Filipino Knights to "sound the alarm" when they suspect human trafficking. The Supreme Knight also called for "Indigenous Outreach" to support First Nation projects such as "Build a Bed" and "Coats for Kids." More than 100 beds were built during the Supreme Convention.

Another area that the Supreme Knight highlighted was worldwide disaster relief of more than \$1 million dollars. Mention was of the massive relief effort that 200 Knights provided for Maui last year.

There are 72 military Councils worldwide. I have had the honor to perform duties as the District Deputy in Europe and as the District Master in the Far East. As Veterans we know the importance of having a Priest to confide in, the brother to talk to, and a Catholic Community to pray with. The Knights will be forever present to fight for our religious liberty.

Ukraine was the next topic addressed by the Supreme Knight. Over 8.5 million pounds of relief supplies have been delivered by K of C Charity Convoys. Our Polish Knights are welcoming refugees and keeping Mercy Centers and Charity Convoys operating.

Our insurance and investment programs have earned top grades from AM Best for 40 years and

S&P awarded our programs a superior rating. The KofC now manages more than \$2.2 billion for dioceses, religious=s and Catholic families.

Our commitment to Pro-Life efforts is an ongoing battle. As the Supreme Knight stated "Today the work is even harder. But it does not matter how hard it is or how long it takes – we will never stop building a culture of life!"

Church support and Faith Formation is our testimony to true love. The vocations support program (RSVP) has received more than \$4.1 million for formation of seminarians and women religious around the world. To date, more than 650 councils have started Cor – with nearly 4,000 more ready to start this movement.

A final topic presented by the Supreme Knight was our involvement and support of the National Eucharistic Revival. He spoke of his own experience helping carry the canopy through the streets of New York City, with onlookers kneeling, crossing themselves as the Eucharist passed by.

The Supreme Convention is a time to recharge, refresh and escalate our Faith. The excitement during the States dinner, the awards ceremony and the Supreme Knights report is magnificent. It is plain to see after this convention that we, as Florida Knights, are an integral part of the entire Knights of Columbus. This convention not only celebrated past achievements but also set a forward-looking agenda for continued service and growth. Indeed, we are "on mission."



Florida Bishops Oppose Extreme Abortion Amendment Vote No on Amendment 4

Florida Amendment 4, which will appear on Florida's November 2024 ballot, is an extreme proposal that legalizes fullterm abortion with no protections for the preborn child, including when the child is capable of feeling pain. This proposed amendment to our state constitution would prohibit all restrictions on abortion before viability and create a broad exception that any healthcare provider could exploit to allow abortion up to birth.

Furthermore, the amendment would effectively overturn or seriously jeopardize common-sense state laws that have regulated abortion for years. These include basic health and safety requirements for clinics where abortions are performed, requiring a physician to perform abortions, informed consent requirements, laws limiting public funding of abortion, and parental consent requirements before a minor's abortion. These risks demonstrate the extreme nature of the amendment.

We urge all Floridians of goodwill to stand against the legalization of late-term abortion and oppose the abortion amendment. In doing so, we will not only protect the weakest, most innocent, and defenseless of human life among us but also countless women throughout the state from the harms of abortion.

Human life is sacred. The dignity of the human person is the foundation of a moral vision of society. Direct attacks on innocent persons are never morally acceptable, at any stage or in any condition. In our state, human life is repeatedly being destroyed by abortion. Over 84,000 vulnerable and voiceless children were aborted in Florida in 2023.

This matter concerning the respect for human dignity and the fundamental value of human life is of grave importance to both our Church and our state. The threat of abortion remains our pre-eminent public policy priority. Therefore, we support a coordinated campaign to mobilize against the proposed amendment. To this end, we offer this prayer to defeat Amendment 4:

Ever-living God, you give life and desire a future for all your children. Take hold of our nation, state and community and awaken in every heart awe for the gift of life. Send your Spirit to strengthen us with wisdom and fortitude as we defend mothers and children in Florida from laws that disregard their health and safety.

Mary and Joseph trusted in you and welcomed Jesus into our broken world. God Almighty, we ask their intercession to protect the preborn and their mothers, and to guide all parents in raising their children. May they help us build a civilization of love by upholding the sacredness of life and accompanying pregnant women in need.

We ask this through Christ, our Lord. Amen.

Obispos de la Florida se Oponen a la Enmienda Extrema sobre el Aborto Voten No en la Enmienda 4

La Enmienda 4 de la Florida, que aparecerá en la papeleta electoral de la Florida en noviembre de 2024, es una propuesta extrema que legaliza el aborto a término sin ninguna protección para el niño antes de nacer, incluso cuando el niño es capaz de sentir dolor.
