

State Ultrasound Initiative

ne of the main objectives within the Knights of Columbus is to protect and defend life. The Knights of Columbus Ultrasound Initiative provides much-needed ultrasound machines to qualified pregnancy resource centers and pro-life medical clinics. Local councils and assemblies raise half the cost of a machine or mobile ultrasound unit; the Supreme Council, through the Culture of Life Fund, provides the rest. (For councils that entirely fund or refurbish a new mobile unit, the Supreme Council will fund up to 100% of the vehicle's ultrasound machine.)

Since the flagship pro-life program was launched in January 2009, Knights in the United States and Canada have helped place more than 1,900 machines, worth a total of \$91 million. They are on pace to reach 2,000 machines by the end of 2025. Here in Florida, over 135 ultrasound machines were completed through May 2025. This could not be possible without the commitment to life by Knights across the state of Florida.

With Life being one of the Knights of Columbus' four core programs, councils remain committed to the cause by fundraising to purchase a new or replacement ultrasound machine. Why? The main reason is that through the ultrasound machine program, these machines are vital to a successful and healthy pregnancy. Through a ultrasound image we can change hearts and minds – it has been estimated that as many as 80% of abortion-minded women who see an ultrasound image of their womb do not go through with an abortion.

For this fraternal year, let's commit to the ultrasound program by reaching out to the pregnancy centers in our communities:

Does the pregnancy resource center need a new ultrasound machine?

Has the pregnancy resource center expanded to a new location where a new ultrasound machine might be needed? Does the pregnancy resource center want or need a mobile ultrasound unit?

Does the pregnancy resource center have a need to replace an older ultrasound machine? Ask when the ultrasound machine was last purchased.

Through these questions, we can understand what the needs are for the ultrasound program in the communities in which we live. HELPING LIFE PROGRAM.

The Florida State Council's Helping Life Fund works closely together with the Ultrasound Initiative program to ensure that much needed funds are distributed where most needed. The fund provides state-wide support to pregnant women, especially those experiencing unexpected pregnancies, and helps new mothers and their babies. Your donations help them---and the pregnancy resource centers and maternity homes that assist them.

For moms, the Helping Life Fund helps provide testing, choices counseling, medical clinic support, of course ultrasound viewings, financial assistance, ongoing maternity training, encouragement, support, and sometimes housing.

For pregnancy resource centers, the Helping Life Fund provides monies to acquire, train staff, maintain, and repair all office equipment including ultrasound machines, as well as to help pay for medical care, medical supplies, and financial and counseling resources for their clients, since they generously provide these services free of charge.

The need for such support is greater than ever. Even after the favorable Supreme Court ruling in the Dobbs case three years ago, more than a million babies are still being tragically aborted every year, with 63% being aborted by using the

chemical abortion pill. The pregnancy centers that the Helping Life Fund supports are often the first line of defense, of support, or of reassurance for a woman facing an unexpected pregnancy. They need and they deserve our help.

Many Councils are already extremely generous in holding diaper and baby supplies drives, and fundraisers that support their local-area pregnancy support centers. This is wonderful and lifeaffirming work, and must continue.

But the Helping Life Fund expands the reach of a local council's efforts far beyond their local area, to those clinics state-wide who may not receive any local council support and where the needs are the greatest. And councils will of course receive Faith in Action-Life program credit for its donations to the Helping Life fund for pregnancy support centers, simply by noting its council number on the donation form and completing a Form 10784.

Donating is easy. Go to www.FloridaKofC.org, then "Donate," then "Helping Life Fund" to make your one-time or your recurrent monthly donation. There are many wonderful and worthy charities out there, but Florida K of C Charities Inc should be at the top of all of our lists.

Finally, once per year all State Members will receive a supply of mailing labels asking to lift our voices in the celebration of life. Please be generous! Even a modest donation from the majority of our membership will allow us to provide much-need funds all across the state where needed most.

This support should be a part of every council's and every Brother Knight's commitment to supporting a greater culture of life. Please make donations to the Ultrasound Program and to the Helping Life Fund a part of your plans for this fraternal year.

Remember to plan your membership drive well ahead of the event. Get permission from your Pastor, order materials and schedule your members to participate. The Supreme Council has guides to help you organize and conduct your membership event.

As Knights of Columbus, we pledge to abide by the Precepts of the Catholic Church. It is a good idea to review them from time to time, especially before conducting a membership drive, in order to be able to explain to prospective members what it means to be a "Practical Catholic."

Precepts of the Catholic Church:

 To attend Mass on Sunday's and Holy Days of Obligation, and to rest from servile works.

- To observe the days of abstinence and fasting.
- To confess our sins to a priest at least once a year.
- To receive Our Lord Jesus Christ in the Holy Eucharist at least once a year during the Easter Season.
- To contribute to the financial support of the Church, each to his own ability.
- To obey the laws of the Church concerning Matrimony.
- To participate in the mission of Evangelization of Souls – (Missionary Spirit of the Church).

Finally, while conducting your membership drive, should you encounter a prospect who is not a "Practical" Catholic, take the time to introduce him to a priest or deacon and invite him to consider the Order of Christian Initiation of Adults program.

A Strong Start Built on Faith

s the Florida State Council of the Knights of Columbus steps confidently into the fourth month of the 2025-2026 fraternal year, the spirit of renewal is alive and well across the state. 

Behind every charitable effort is a bond fraternity that gives the Order its unique strength. Brotherhood among the Knights is more than friendship; it is a spiritual kinship forged through shared mission and sacrificial love. Councils across Florida are investing in fraternal life organizing retreats, men's conferences, family and father-

men's conferences, family barbecues, and fatherson events that draw members closer together. In a world that often isolates men, the Knights provide a place of belonging, accountability, and encouragement.

outstretched hands an open mantel. She was beckoning the people to take refuge under her mantel. The people huddled under the mantel, and the Ottoman army did not enter the city.




We can see then why our veneration of Mary is appropriate because motherhood brings with it respect,

Council Donates 60 Wheelchairs

ur Lady of Hope Council 8086 of Port Orange recently held its first Wheelchair Weekend, resulting in donations of more than \$9,000 that will enable the Knights of Columbus to purchase at least 60 wheelchairs, giving the poorest of the poor the gift of mobility.

While each wheelchair costs \$500-plus, the Knights purchase them in bulk, reducing the cost to \$150. Since 2003, the KofC has delivered more than 100,000 wheelchairs throughout Mexico, the Holy Land, Latin America, Vietnam and other countries, in addition to U.S. Veteran and local

needs throughout the United States. There are more than 100,000 people worldwide who cannot afford a wheelchair. Each wheelchair impacts an average of 10 lives.

Council 8086 Delegates DGK Vito Benedetto and Chancellor Adam Schmidt were very impressed with the Wheelchair Mission presentation and display at the Florida State Council Convention in May, and brought back the recommendation that the Council hosts a Wheelchair Weekend. Under the direction of GK Ernie Jackson, Program Director Tim Mell met with State Wheelchair Chairman Michael Costanza, who loaned the Council two wheelchairs, the display and additional information.

Louis Prevost Captivates Assembly

Father Claudio Stewart recently introduced Louis Prevost – older brother of Pope Leo XIV – and his wife Deborah following Mass at St. Maximilian Kolbe Catholic Church in Port Charlotte. Originally planning to talk for about five minutes, the Prevosts gave their impressions and answered questions for about 45 minutes. Included in the congregation was Sir Knight Kellmis Fernandez, Florida State Multi-Cultural Director for the Knights of Columbus, who spoke with him and told him about the Knights of Columbus, extending an invitation to join the order.

Fernandez then set up a formal Zoom meeting interview with Mr. Prevost conducted by PSD and KofC Supreme Director Scott O'Connor and himself. The interview lasted nearly two hours.

The first part of the interview was published in the August issue of the Invocation.

cott O'Connor – Tell us a little bit about yourself and your family, and how you decided to come to Florida, and anything else you want to add.

Louis Prevost – While we were living up north, I contracted a blood cancer that attacked my bones, in the marrow. I was going for months with horrible pains in my legs, in my back, neck, shoulders. I had been to three or four doctors, and they did all these different tests, and they couldn't find anything, only giving me medicines to take the pain away. Finally, one day I woke up, and I couldn't move. I was paralyzed, and in horrible pain all through my body.

What woke me up was my office was calling after hours, and I needed to get on my computer and do work. But I wasn't able to move and I thought, something's really wrong. Holy cow! Why can't I move?

Well, that went on for some time, I finally, I managed eventually to roll my way out of bed. I got to my computer, I was basically just kneeling on the floor with the computer on the bed and just



moving my arms and fingers to type, and I thought "This is bad." That was in June of 2017. On July 4 of that year, Independence Day, we were supposed to go to my brother John's for a barbecue picnic, and again, I woke up and I couldn't move. I was stuck again in bed, and my wife's saying, "that's it, you're done." She dragged me out of bed, helped me get dressed and took me to the Urgent Care in Kenosha, Wisconsin.

They got me in, and they ran all kinds of tests, took X-rays, and came back with the same (diagnosis). There's nothing there. Everything looks good, have some oxy (OxyContin) but I still was dying from the pain. They also said, "Or if you want, you can go over to the Emergency Room. Now we've been there (Urgent Care) like four or five hours already. I was ready to get in the car and go home. Thank God, my wife again saved my life. She dragged me over to the ER, where

they put me through another five or six hours of tests. They drew lots of blood, took lots of X-rays, it was now in the evening.

Then we were put in a little room and told that the doctor will be in to talk to you in a minute. He's going over the results of all your tests. We're sitting there for what seemed like an eternity and I thought "let's just go, they forgot about us." But my wife said we're not going anywhere until we find out. And I said, "You watch. They're going to come in here and tell me I've got terminal cancer. I've got three weeks to live.

Honest to God! It wasn't 20 seconds after I said that there was a knock at the door. Guy opens the door and says, Mr. Prevost, "yes". I am sorry to tell you. You've got malignant multiple myeloma. Here's an oncologist card we recommend. I would go home, make your final preparations, and get your affairs in order. Good luck, and he walked out. And so my jaw dropped open. My wife is balling, oh, my God! And it's what a way to you know you like to hear the news. But what a way to present it! You know you got three weeks good luck.

So, we did that at the at that time Deb was working for AbbVie. If you're familiar, they're a spinoff from Abbott labs.

We made an appointment with the oncologist. He did some tests and then he sent me for different kind of X-rays and scans that they hadn't done in the past. The oncologist said, "I don't understand why they didn't do whatever it was. But you need to go do this test so we can see what's going on. It was an MRI and a CT scan. I think. So, we went back to the hospital emergency room, and they did those tests.

Now I'm walking around, I'm on the oxy, so I have no pain right. I'm having a good old time I'm working away doing stuff at home around the house. We went out to have lunch at a Golden Corral up in Kenosha. When you go inside the restaurant, there's no cell phone service. I think they've got it locked down so people don't you know yak on their phones while other people are eating. When we came out of the restaurant, both our phones were blowing up. We heard urgent messages from the hospital to "Come back right"

away! Come back right away!" That's all they said.

We jumped into the car. Went back to the hospital. I pulled up and there's a nurse out there waiting for us, she is waving to us "come over here, come over here." So we drive around to where she was, two guys and two girls show up. They open the passenger door and one of the girls reaches in, puts a neck brace on me. The guys drag me out of the car, and put me on a gurney, then they shoved me in the back of an ambulance, and away we went, to St. Luke's in Milwaukee.

Well, it turned out those scans showed my neck was broken in two places. Some of the vertebrae had been eaten into (the shape of) an arrowhead. It had pushed into my spinal column and that's what was causing the pain and paralysis. Because depending on where that (arrowhead) was pressing, the whatever circuit in my spine was shorted, and I was stuck in great pain.

As it turns out, when I got out of the ambulance, they got me, boom, right into surgery. After the surgery, when the doctor came out to explain what they found and what happened.

In my mind I am thinking that the first miracle was that my wife insisted we go the clinic. Miracle two was when somebody actually looked at the x-rays and said, Holy crap! He's got a broken neck in two places. Then then the third miracle was that I had a great surgeon who was available at 2:10 in the morning to come in and do this operation.

The doctor then told me, after I had woken up later that morning, all that had transpired. He said, "The first thing to do when you get out of here is go to church and say a prayer, because I don't understand why you're not a paraplegic, or a quadriplegic." It was that bad. "I don't understand how you're not totally paralyzed after what we had to do to fix your spinal column in your neck."

And he showed me the pictures, and I'm like, Oh, my gosh! So, prayer worked in my mind for me. I'm ambulatory. They fixed my neck and now, all they had to do was battle the cancer somehow. But yeah, that was incredible. And when I woke up I was feeling no pain, like I was still on the pain drugs, and they said, No, you're not on pain meds. I'm like, "Well, I have no pain

So, for the next few years I was going back regularly to have that stuff looked at, X-ray's and tests. This was to make sure the bones (cadaver) were adapting and healing and not deteriorating. They were also checking on the spread of the lesions that previously were eating the bones. They had kind of slowed down and/or stopped. So, it was all good, and we resumed normal life. While my wife was at AbbVie she talked to some of the doctors there and she gave him the whole background. The fellow at AbbVie then said "that's not good enough, you got to find another doctor that treats it more aggressively." They said, "Go see Dr. Hari at Froedtert, he's a leading expert in the Myeloma field". So we did, and he did some magic. He got me into a couple clinical trials. That was July 2, 2017. It's now July 22, 2025. I'm still here. I'm active, I'm pain free, I'm working full time.

Right around the time Covid was starting to break out I told my doctor there at Froedtert that we were thinking about moving to Florida because the cold weather really hurts. The doctor said if you're going to move to Florida, we need to stay near Tampa because I want you to go to Moffitt for your treatment down there.

When Covid came out, work told me that I may not want to come into the office with all the people here, and I might want to stay home. I said, "Does it matter where my home is?" It took about a week for him to say "no, probably not, why?" "I said, well, we're moving to Florida." And then they went, I guess it doesn't matter. Go ahead.

So we started scoping the area close enough to Tampa when another miracle happened. We were dejected because we couldn't find a anything we could afford. We were driving when we learned that a new house just came on the market, within a half mile of where we're at. We found the house empty and abandoned. We walked up to the windows and my wife looked in the front door. You could look in the front, look clear through the back. See the lanai, see the pool, see the backyard, and then see the empty lot behind it, and see the woods across street. It was beautiful. We made an offer, lower than the asking price, that was denied. We started heading, driving back towards Chicago

and we were in Kentucky when the phone rang, and it was the agent saying, "they have a counter offer." We went back and forth several more offers and when we got to our home in Illinois, the phone rang the next day and the agent said, "they have accepted your offer."

We then rapidly packed stuff up and came down here. And that's what drove it, my health and to get out of the cold. Since they (doctors) did not want me in the office at work, and we found a place that worked for us. Here we are.

Scott O'Connor – What a great story, especially the part about your being in remission!

Louis Prevost – I remember thinking "I'm not a quitter! I'm going to beat this. I don't care what they say. Damn it. we're going to do this, let's fight, let's fight", and you just gear up and you go for it. It's another reason why, at my age, I'm still working full time. My doctor told me, "Whatever you do, don't stop working, keep active, keep your mind going and keep your mind off what you got." You'll be 100% ahead of the game. I can't imagine to just retire, what would I do? I need to be mentally aware and awake and active, and not just turn to a couch potato.

Kellmis Fernandez – You don't have to worry about that (retirement and what to do), Lou, because if you retire and you decide to join a Knights of Columbus council, we'll find stuff for you to keep you busy!



Fourth Degree Exemplification in Wildwood

nights will have the opportunity to take the enhanced Fourth Degree Exemplification Ceremonial at St. Vincent de Paul in Wildwood on November 1, 2025.

The Fourth Degree is celebrating its 125th anniversary, with the celebration beginning on Washington's Birthday with a class of 650 new Sir Knights in a stirring ceremony at St. Patrick's Cathedral. Since then, the Florida District has hosted Exemplifications in Lakewood Ranch, Palm Beach Gardens and St. Augustine, joining the select group to meet the "125 for 125" objective.

The Fourth Degree of the Knights of Columbus was founded in 1900 to embody the virtue of Patriotism. The Fourth Degree is available to all third degree members in good standing who are citizens of the country they reside and wish to grow in their practice of Catholic patriotism.

St. Vincent de Paul is located at 5323 East County Road 462 in Wildwood. Registration begins at 9 a.m., with the Exemplification ceremony starting at 11 a.m. The Banquet begins at 2 p.m., followed by the Vigil Mass at 4 p.m.

For the first time, the new Exemplification ceremony is open to spouses, family and guests.

All forms for the degree must be received by the Master by January 17, along with banquet reservations. The initiation fee is \$90, including one banquet ticket (\$50 for Priests and members of a religious order). Additional banquet tickets are \$50. Assemblies should fill out the proper form, along with a Form 4 application for each candidate, along with one Assembly check payable to Master Robert Urrutia. The correct forms and additional information are available under the Fourth Degree tab on the www.floridakofc.org web site.

Candidates must wear a dark suit and tie, with a plain white shirt and black shoes. Religious may



wear their clerical garb. Members of the armed forces or full-time police, and firefighting officers may wear their respective dress uniforms. Fourth Degree members shall wear official dress plus social baldric, lapel pin and current jewel of office.

The next scheduled Florida Exemplification will be on January 31, 2026, at St. Mark the Evangelist Church in Tampa.

trategies Councils and Assemblies Can Use for a Supporting Presence in Veterans' Lives. Determine what activities and interactions Councils and Assemblies are currently having with Federal, State and various Veterans' Organizations in your geographic location by reaching out to those Councils and Assemblies in your area. This can be facilitated through your Regional Administrators and the District Deputies in their Assigned Region.

The various organizations would be the local Honor Flight Association flying Veterans to Washington, D.C. Memorials; the Missing in America Project burying deceased homeless veterans with military honors at National Cemeteries; American Legion; Veterans of Foreign Wars, etc.

At the VA Medical Centers, Assembly and Council Members, Columbiettes and parishioners can become volunteers after background screening and some basic training at the Center for Development & Civic Engagement (CDCE). Check with the Catholic Chaplain to see if KofC volunteers can distribute Communion to hospitalized veterans throughout the hospital, bring the disabled veterans in wheelchairs and escort veterans using canes or walkers to the chapel for Mass on Sunday and Holy Days of Obligation.

Determine the Veterans Affairs Medical Center (VAMC) Facility in your area and obtain contact information of the Chief, Center for Development & Civic Engagement (CDCE) and his team members and whether there is a Knights of Columbus Representative and Deputy Representative for Veterans Affairs Volunteer Services (VAVS)



assigned by the Master of the Fourth Degree and Supreme Master to that VA Medical Center. If there is a vacancy, the local KofC Assemblies should select Fourth Degree members to be Knights of Columbus VAVS Program Representative and Deputy Representative, preferably veterans who honorably served in U.S. Military Services. These candidates and all volunteer candidates will be subject to background screening.

At the Catholic Churches in your local area, or in your residential communities, Councils and Assemblies can decide if their members are willing to make their members available to help elderly and disabled veterans by bringing them to church, bringing them Communion, taking the veterans to Church activities, to hospital appointments, taking them out for meals or bringing them a meal from a restaurant or fast-food place or going to a movie. If so, let your Pastor and his staff know and see if they are willing to let your brother Knights be there to support our veterans.


