OCTOBER IS DEDICATED TO THE ROSARY -

VOTE “NO” ON AMENDMENT 4 -

(The following are excerpts from the video message of Bishop Dewane on the dangers of Amendment 4.)

Dear Brothers and Sisters in Christ,
News of Amendment 4, a dangerous pro-abortion amendment which will appear on the Florida ballot this fall, has no doubt reached you by now. The amendment is misleading in its language, and dangerous not only for full-term babies, but women, and girls. It is my hope that once you look into the facts of this proposed change to Florida’s state constitution, you will unequivocally vote “no” in November.

. . . Why vote “NO” on Amendment 4? Titled “Amendment to Limit Government Interference with Abortion,” this amendment would embed unregulated abortion in the state constitution, establishing an unlimited right to abortion throughout the pregnancy, making Florida one of the most pro-abortion states in the nation. Amendment 4 would allow for second and third trimester abortions, a stark contrast to Florida’s current Heartbeat Protection Law which allows abortion up until a heartbeat can be detected, at about six weeks.

This amendment allows for abortion for any reason, including consideration of the “patient’s health,” which is undefined in the amendment. Current Florida law includes an exception for when the pregnant woman’s life is in danger, among many other exceptions. Further, Amendment 4 puts not only babies, but women and girls at risk. The amendment weakens the current medical doctor requirement, allowing “healthcare providers,” not just physicians, to determine if an abortion is necessary to protect the mother’s health. This is dangerous for women. The Amendment also eliminates the currently required parental “consent” for a minor to have an abortion, preserving only parental “notification.” This is reckless, and destructive, for girls, and their families. In short, Amendment 4 goes dangerously beyond even what was permitted in the Roe v. Wade ruling. It is extreme, and unnecessary. . .

Some have said that the Church has no place in politics. It is true that the Church would never suggest you vote for a particular candidate. However, in this election year, it is critically important to remember that shaping the moral character of society is a responsibility of people of faith, and a basic part of the mission we have received from Jesus Christ. In this case, when confronted with such a clear threat to human life and dignity, the Church must not be silent and simply cannot remain on the sidelines. Let us unite in prayer to defeat this expansive, pro-abortion amendment, and vote “NO” on Amendment 4 in November.


Grand Knights Report

October is the Right to Life month and our guest speaker will be the Worthy Art Reilly.






Hope to see you there. Let's get fired up to save babies and defeat Amendment 4 this fall.

NEWS FROM OUR FRATERNAL FINANCIAL ADVISOR

Brothers,

When Father McGivney founded our Order, a key part of his mission was to help Catholic families attain a secure financial future. It was a hard time and place to be Catholic, but he didn't want them to feel they had to let go of their Catholic identity in order to find that stability. He wanted them to see their Catholic community as a place of security – to know that here, their faith could grow. And here, their families would be protected.

In keeping with that mission, Supreme Knight Patrick Kelly recently announced updates to our member benefits. Now, you might not even remember you have these benefits – in a sense, they're the best kept secret of the Order, but I'm going to do my part in making sure they're more widely known. I'd like to highlight some of these updates, starting with one that affects all of us.

Whether or not you are an insured Knight of Columbus, you are entitled to the Member/Spouse Fraternal Benefit. This is an accidental death benefit for all members in good standing and their spouse. The benefit amount varies from \$1,500-\$5,000, depending on your age, whether you are insured and how long you've been a member. The second update I'd like to call out is the Family Fraternal Benefit, which applies to insured members. It's guaranteed-issue insurance up to \$10,000 to any child under age 18, regardless of physical or intellectual disabilities. This also includes an automatic \$5,000 death benefit for children who die before age 61 days, including stillbirths from at least 20 weeks after conception.

Next is the Orphan Fraternal Benefit, which provides \$500 monthly to an insured member's child who has lost both parents, up to age 19. This benefit also includes up to \$5,000 per year in college scholarships, with a maximum total of \$20,000, per eligible orphan. Finally, the Widow Benefit offers surviving spouses of insured members the opportunity to purchase life insurance, long-term care insurance, disability income insurance or annuities, and she and her children are eligible for scholarships.


