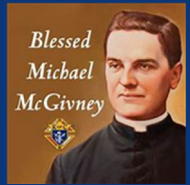

Spiritual Advisor Message – SK Deacon Bruce Gesinski

**The Passion and Resurrection of Jesus Christ:
Who Am I?**

As we reflect on the Passion of Christ and on Easter, we should also reflect on who we are. There are many different voices, many different roles in the Scriptures of the Passion. We should be asking ourselves, “Which of these am I? How many of these roles have I played and do I play?”

Am I one in the crowd rejoicing at Jesus’ entry into Jerusalem? Remember most in the crowd were also the ones calling for Jesus to be put to death a short time later. Do I just go along with the crowd, or am I confident with who I am as a Catholic?

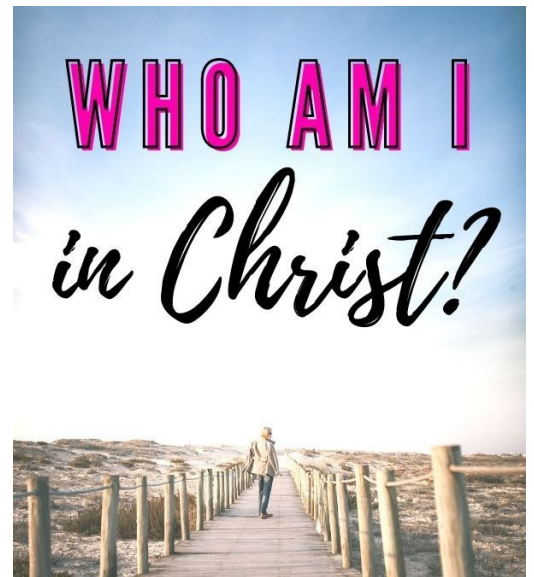
Am I the woman who anointed Jesus while he sat at table? She was admitting her sins and asking for forgiveness in front of everyone. Am I willing to do that?

Am I one of the Apostles at the Last Supper? When Jesus said that one of them would betray Him, each had a reason to ask, “Is it I, Lord?” Do we have a reason to ask the same thing?

Am I Peter, James, or John whom Jesus invites to go pray with Him and asks them to keep watch, and then fall asleep while Jesus is praying in the garden and counting on me? Am I always attentive to what God has planned for me and do I live my life accordingly?

Am I Peter who, after Jesus is arrested, tried to follow Jesus but when he was in fear of his life, denied Jesus? Do I always proudly act Catholic? Do I always act the same everywhere as I do at Church, or do I act differently when I am with certain friends or coworkers, or when I am out in public?

Am I one of the apostles who abandoned Jesus until Easter and the resurrection? Am I going to do that now? Am I abandoning Jesus until Easter? Or am I coming to the Mass of the Last Supper on Holy Thursday evening? Am I coming to the Good Friday service and Good Friday Stations? Will I participate in the Easter Vigil? Will I be at the Easter Vigil to be present and support those who have been studying and praying and who will become part of the Catholic Church at the Easter Vigil Mass?



Am I one of the soldiers who mocked Jesus, abused Him, pushed Him to carry His cross, and then nailed Him to the Cross?

Am I one in the crowd at the crucifixion mocking Him? Asking Him, “Aren’t you God? Come down from there!” Do I look around at the world today, at the state of morality in our society, and at the Catholic Church and say to Jesus, “You saved others, but You cannot save yourself?”

Am I one of the thieves who, at the end of my life - after living a life that was not the life I should have been living - asks Jesus to save me?

Am I the centurion who finally kind of gets it and says, “Truly this man was the Son of God!” But he really didn’t completely get it because the statement should have been, “Truly this man IS the Son of God!”

Am I Joseph of Arimathea, who was a disciple in secret for fear of being discovered, who at the end, steps forward and courageously asks for Jesus’ body so he can bury Him?

As we reflect on what role we play in life and in the Catholic faith we should ask ourselves, Am I the person I want to be? Am I the person I need to be? Am I living the life I am supposed to live? I am the person I was created to be? Am I living my life for and in Christ?

The Wilderness Within: A Carmelite Reflection on Jesus’ Temptation

The desert is a place of silence, of stripping away all but the essential. It is here that Jesus, weakened by hunger but strengthened by prayer, faces the adversary. The temptations He encounters—bread for His hunger, a public miracle for recognition, and earthly power for dominion—are not merely external tests but revelations of the inner battle every soul must fight. To follow Christ is to pass through this same desert, where we are called to let go of attachments and find our true strength in God alone.



St. John of the Cross: The Purification of Desire

The first temptation, the hunger for bread, speaks to our longing for security, for the comfort of what sustains us. *“If you are the Son of God, command that these stones become bread”* (Mt 4:3). It is the same voice that whispers to us: *“Seek satisfaction, fill the emptiness, grasp what is at hand.”* But Jesus refuses. He knows that man does not live by bread alone. He shows us that the soul cannot be fed by earthly things.

St. John of the Cross would call this the first step of detachment from sensual goods—not that food or comfort are evil, but that they cannot be our foundation. The soul that clings to created things, he writes, *“cannot soar to the heights of the spirit”* (*Ascent of Mount Carmel*, I.4.4). Jesus’ rejection of the tempter’s offer is not a denial of His human needs but a revelation of freedom: He possesses Himself completely because He is possessed by nothing but the Father.

St. Thérèse of Lisieux: The Desire for Recognition

Satan then takes Jesus to the pinnacle of the Temple. *"If you are the Son of God, throw Yourself down, for it is written: 'He will command His angels concerning You...'"* (Mt 4:6). Here, the temptation is more subtle. Be seen. Be known. Let God prove His favor visibly. How often do we long for confirmation of our worth? How often do we wish to be noticed, understood, or reassured?

Yet Jesus does not seek spectacle. He does not need to test the Father's love, for He dwells within it. This is the detachment from the need for validation. St. Thérèse of Lisieux, who embraced the hidden path of love, teaches us that holiness is not about being recognized but about trusting the unseen grace of God. *"To be little is to recognize one's nothingness, to expect everything from the good God"* (Story of a Soul, Manuscript B, 1). Jesus shows us that true greatness is not found in proving ourselves but in resting securely in the Father's will.

St. Teresa of Avila: The Illusion of Control

Finally, the devil unveils his last offer: power. *"All these I will give You, if You will bow down and worship me"* (Mt 4:9). It is the temptation to rule, to control, to take dominion over the world rather than submit to the Father's path.

St. Teresa of Avila, who fought her own battles against the illusion of control, reminds us that true power is found in surrender: *"Let nothing disturb you, let nothing frighten you, all things are passing; God never changes"* (Poems, 30). Jesus refuses the kingdoms of the world because He reigns over a kingdom not built by human hands. He possesses all things precisely because He clings to nothing.

St. Edith Stein: The Triumph of Self-Possession

At last, the tempter leaves, and angels minister to Jesus. He has emerged not only victorious but whole, untouched by the illusions of desire, approval, and control. St. Edith Stein, reflecting on the nature of detachment, saw it as a journey to authentic self-possession: *"Whoever truly seeks truth must strip himself of all attachment to self"* (Self-Portrait in Letters, 1931). Jesus, fully detached, is fully Himself—and because of this, He is free to love completely.

This is the lesson of the desert: detachment is not about renouncing joy but about reclaiming the freedom to love as Christ loves. To walk this Lenten path is to strip away all that weighs us down—not only sin but every false security, every need for recognition, every desire for control—until we, too, can stand in the silence of the desert and say: *"You shall worship the Lord your God, and Him only shall you serve."*

Each month, Archbishop William Lori – Supreme Chaplain of the Knights of Columbus – selects a brief passage from the Gospel reading of one of the Sunday Masses of the month. Archbishop Lori shares a brief reflection on the passage and issues a challenge for men to live for the month. The next month, men undertaking the challenge as a group gather and share their experiences living the challenge. The Supreme Chaplain's Monthly Challenge is suited for *Cor*, but can also be done individually. By taking up the Supreme Chaplain's Monthly Challenge, men take direct, concrete action to grow in their faith and help their brothers do so as well.

This Month's Challenge:

"A good tree does not bear rotten fruit, nor does a rotten tree bear good fruit. For every tree is known by its own fruit. For people do not pick figs from thornbushes, nor do they gather grapes from brambles." (Gospel for March 2, Lk 6:43-44)

Scripture often reminds us that our faith must be made evident through our works, through the good that we do. If we are truly prayerful and holy in an interior way, we will also be productive in the world. Like a tree, we will be known by the fruit we produce. May we always be mindful that faith calls us to lead lives of virtue in service to God and neighbor.

Challenge by Supreme Chaplain Archbishop William Lori:

This month, I challenge you to prayerfully identify at least one area of your life where you could bear better fruit. Then, guided by the Holy Spirit, undertake at least one concrete resolution to improve.

Questions for Reflection:

To borrow an old question: If you were accused of being a Christian, would there be sufficient evidence to convict you? Where do you see room for improvement in turning your faith into action? What opportunities do the Knights of Columbus provide to help you bear good fruit?

USCCB Statement on the Executive Order Pertaining to the U.S. Department of Education

In response to the Executive Order "Improving Education Outcomes by Empowering Parents, States, and Communities," the U.S. Conference of Catholic Bishops (USCCB) offered the following statement:

"While the USCCB does not take a position on the institutional structure of government agencies, the Catholic Church teaches that parents are the primary educators of their children and should have the freedom and resources to choose an educational setting best suited for their child. The Conference supports public policies

that affirm this, and we support the positive working relationships that the dioceses, parishes, and independent schools have with their local public school system partners. As this Executive Order is implemented, it is important to ensure that students of all backgrounds in both public and non-public schools, especially those with disabilities or from low-income backgrounds, will continue to receive the resources they need."



Vatican Update

Pope Francis Returns to Vatican After 38 Days in the Hospital

Immediately before leaving Rome's Gemelli hospital after more than five weeks of treatment for breathing difficulties, double pneumonia and infections, Pope Francis greeted hundreds of people who gathered outside the hospital March 23. With a very weak voice, Pope Francis thanked the crowd, waving his hands and giving a thumbs up. He also pointed to a woman carrying a yellow-wrapped bouquet of flowers and told the crowd, "She's good."

An aide had pushed Pope Francis in his wheelchair onto the balcony overlooking the square outside the hospital. Some 600 people had gathered at the hospital, including Rome's Mayor Roberto Gualtieri. Hundreds of people also gathered in front of video screens in St. Peter's Square to see the pope for the first time since he was hospitalized Feb. 14.

The pope left the hospital almost immediately after his appearance on the balcony. The motorcycle police leading the pope's motorcade turned onto the street leading to the Vatican entrance closest to his residence and then turned around. Rather than go directly home, Pope Francis was driven through the center of Rome to the Basilica of St. Mary Major where he has prayed before and after every foreign trip and after his two previous hospitalizations for abdominal surgery. Pope Francis did not go into the church but left a bouquet of flowers to be placed on the altar under the Marian icon "Salus Populi Romani" or "Health of the Roman People." Television footage of the pope, seated in the front seat of a white Fiat, showed he was using oxygen through a nasal tube.

Just before the 88-year-old pope came out on the hospital balcony, the Vatican released a text he had prepared for the midday Angelus prayer. The pope's message focused on the day's Gospel reading of the parable of the fig tree from Luke 13:1-9, in which a gardener asks a landowner to allow him to spare a fig tree that had not borne fruit for three years; the gardener asks to be given a year to fertilize and care for the tree in the hope that it would bear fruit in the future.

"The patient gardener is the Lord, who thoughtfully works the soil of our lives and waits confidently for our return to him," the pope wrote. "In this long period of hospitalization, I have experienced the Lord's patience, which I also see reflected in the tireless solicitude of the doctors and health care workers, as well as in the attention and hopes of the family members of the sick," who also are in the Gemelli, he wrote.

"This trusting patience, anchored in God's love that does not fail, is indeed necessary in our lives, especially in facing when the most difficult and painful situations," Pope Francis wrote. But, like the other messages he released from the hospital on Sundays, the pope also urged prayers for peace and commented on current events.

Dr. Sergio Alfieri, head of the medical team treating the pope, had told reporters March 22 that in his rooms at the Domus Sanctae Marthae, the pope will continue using oxygen as needed through a nasal tube, will be taking medication to fight a lingering mycosis, a fungal infection, and will be continuing his physical therapy and respiratory therapy. The doctors have prescribed two months of rest and recuperation and have urged the pope not to meet with large groups during that time. They also said his voice will require time to recover. Dr. Luigi Carbone, the assistant director of the Vatican health service and a member of the medical team treating the pope at Gemelli hospital, said that other than an oxygen tank, no special equipment would be needed in the pope's room. He added, though, that the Vatican health service has a doctor and other personnel on duty 24 hours a day.

Even after the pope's return to the Vatican was announced, the rosary for him and for all the sick was continuing in St. Peter's Square each evening. The crowd gathered to pray March 22 loudly applauded when Archbishop Giordano Piccinotti, president of the Administration of the Patrimony of the Holy See, began the recitation telling them, "The Holy Father is returning home. We give thanks to God and to the Virgin Mary for this great news."

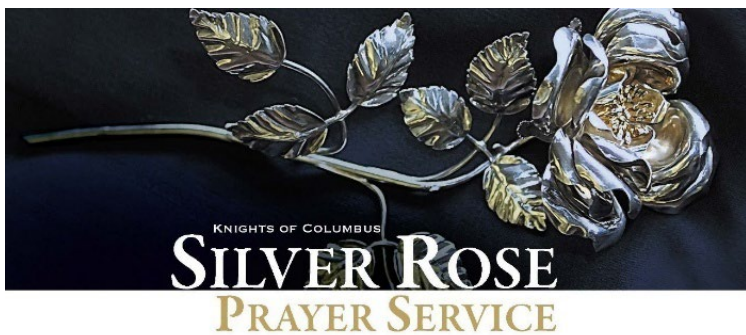

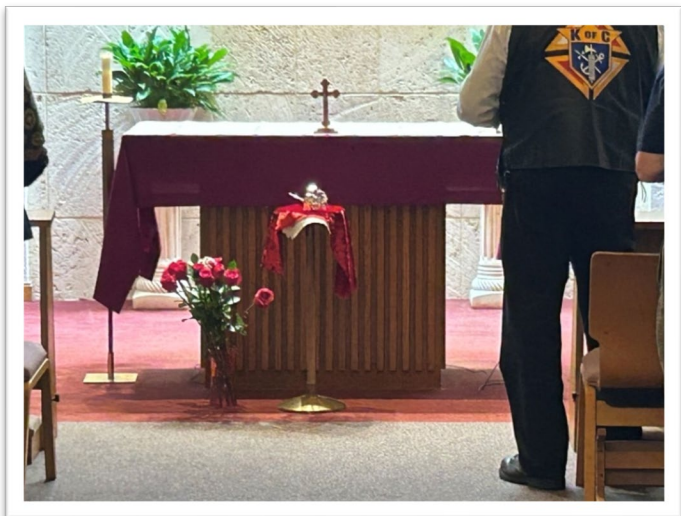

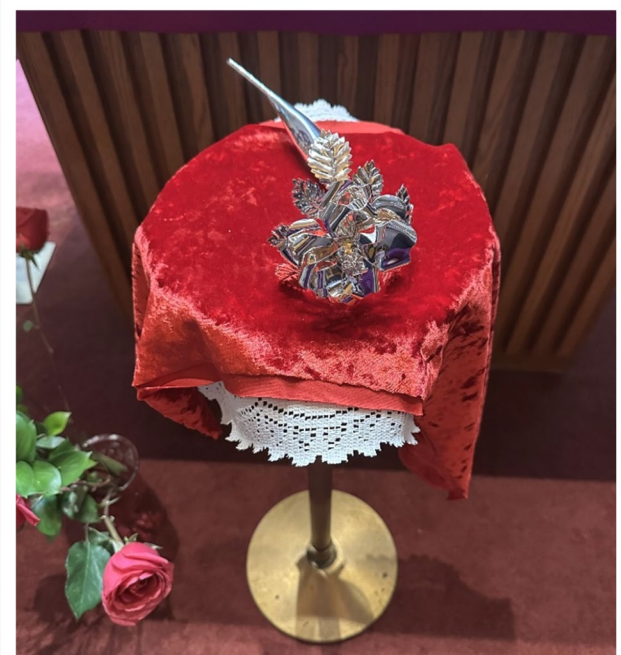

Pro-Life Legislative Session Update

The 2025 Session of the Florida Legislature began on March 4 and continues until May 2. Several Bills were filed and are being considered by both the House and Senate that relate to the protection of life and may be of interest to our Knights of Columbus.

The Unborn Child Parent's Survivor Act (SB 1284), which allows parents to file civil lawsuits for the wrongful death of an unborn child. It recognizes an unborn child as a separate legal entity and extends legal protections to ensure accountability in cases of negligent or intentional harm. The legislation creates new avenues for parents to seek damages for emotional and financial loss resulting from the wrongful death of their unborn child, further humanizing the unborn in state statute. This bill is scheduled for the Judiciary Committee on April 1.

Also, the Initiative Petitions for Constitutional Amendments Reform Act (HB 1205), which strengthens signature verification, limits out-of-state petition influence, increases transparency to protect Florida's ballot process, and makes it much more difficult to amend the Florida Constitution by well-funded outside groups as almost happened with the recent pro-abortion and legalized marijuana amendments that were narrowly defeated in November. This bill passed its final committee and is heading to the House floor for a vote.

Also, the Office of Faith and Community Act (SB 820), which codifies the Office of Faith and Community within the Executive Office of the Governor to build collaborative relationships between faith-based organizations and state agencies. This bill is scheduled before the Government Oversight Committee on April 1.

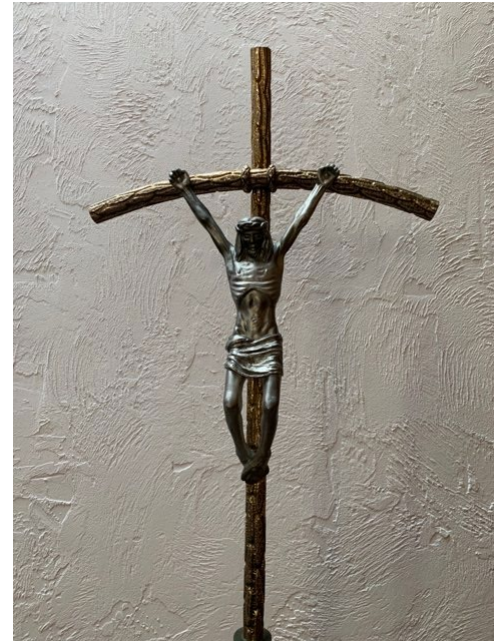

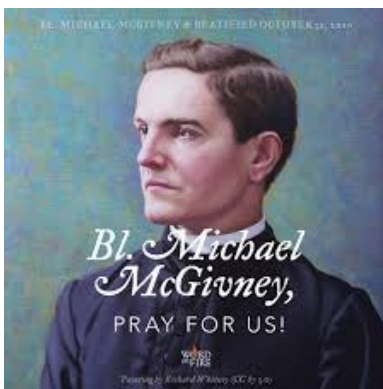
