Knights Sponsor a Farewell Luncheon

On June 29th Fr. Francois Charles, Deacon Ray Sakowski and Deacon Jason Bullman were celebrated for all their service to our parish in an overflow luncheon in the Parish Hall.

Fr. Zach served as host for the afternoon, offering kind words (and a few jokes) as he introduced each of our honorees who offered fond remembrances and grateful thanks for their time at St. Joseph.

Father François Charles, our Parochial Vicar, will be serving a similar role in a large Haitian congregation at St. Andrew's Parish in Orlando starting July 1st. (standrewchurch@standrew-orlando.org). Father Charles has asked to remain a Knight in our Council.

Deacon Jason, a brother Knight and lifelong St. Joseph parishioner, will be serving at Resurrection parish. In his talk, he recalled his life at St. Joseph including his parochial school years and his receipt of the *Sacraments of Initiation, Healing and Service* while at St. Joseph's Parish. He co-founded *The Catholic Men of Lakeland*, a group of Catholic men regularly meeting to pray and practice our Catholic Faith. Additionally, he is a widely published Catholic influencer in his work with *Word on Fire*, an international ministerial organization, and has recently published a book through Ave Maria Press entitled "*Praying with the Psalms.*"

Deacon Ray will now be serving at St. John Neumann in Lakeland. In his brief talk, he recalled his first visit to St. Joseph's church building stating "*it felt like I was home.*" Deacon Ray received his Holy Orders while a St. Joseph parishioner.

Grand Knight Mark Sagen closed the afternoon's program with some much anticipated witty and heartfelt remarks, including the often remembered leg wash story. (Come to our next meeting for the full story.)



Santa Fe Cleanup – Knights in Action

When presented by a request from Santa Fe High School (the Diocese of Orlando’s westernmost secondary school) for assistance in preparing its grounds for a new set of Stations of the Cross plaques, the Brother Knights of Council 2505 immediately began its planning to assist.

The Knights responded to a request made by Santa Fe’s Rev. Deacon George Ferraifi by organizing a work party assigned to remove a long line of mature palm hedges and prepare a worshiper path for students, parents and faculty. The project was completed in one morning, giving the school ample time to prepare for the new Stations to be erected.

On June 1, 1925, the U.S. Supreme Court unanimously ruled in favor of Catholic schools and parental rights, striking down an Oregon statute that required all children to attend public school.
