Address to the Delegates

nce again, I want to welcome all of you to the 120th Annual Meeting of the Knights of Columbus Florida State Council. We are here this weekend to gather in Fraternity, to celebrate the achievements of the past Fraternal Year, to conduct the necessary business of the Florida State Council, and hopefully, in the process, learn something new to bring back to our Council members across the Jurisdiction.

I can honestly say that the past year has been one of tremendous success throughout Florida. As I traveled around the State on our Spirit of Unity tour early in the year, I was tremendously uplifted by the dedication and enthusiasm shown by so many Council leaders for the mission of our Order. And you have followed through with your commitment all year long.

Hundreds of activities have been reported from across the Jurisdiction, including such varied programs as feeding families in need and the homeless, fundraising for pregnancy centers, providing volunteer and financial support for Special Olympics of Florida, and conducting Holy Hours and Eucharistic Processions. And I know that there are many, many more programs that go unreported by Councils. Service programs are at the center of every Council's mission, and it gratifying to see so many Councils taking this to heart.

This has also been a great year for charitable fundraising by Councils in support of our causes. About 70 Councils participated in the traditional Citizens with Disabilities campaign through Florida K of C Charities, collectively raising over \$250,000, with over \$75,000 raised for Special Olympics of Florida alone. 36 Councils raised over \$58,000 directly for the American Wheelchair Mission. Over 100 Councils contributed \$180,600 to support 261 seminarians through the Order's RSVP program. As of May 1, 56 Councils this

year have participated in the Order's Aid and Support After Pregnancy program, otherwise the ASAP. known as supporting program, pregnancy centers and maternal homes, and have raised over \$213,000, which currently puts Florida number one in the Order! And that doesn't even count our State fundraising campaign

in May for seven pregnancy centers serving the poorer areas of each Florida Diocese, which has exceeded \$54,000 so far! As for Ultrasound projects--\$390,000 has been raised for 7 projects that have been completed or approved by Supreme, with another 3 under review and 2 more underway!

I also know that many Councils have taken on the new Cor initiative to introduce spiritual development into our activities. While we don't have any good statistics on Cor, I do know that many Councils have reported tremendous success with Cor. As Catholics, Knights of Columbus should never ignore the spiritual component of our work, and Cor is great way to systematically incorporate spiritual development into the life of a Council.

It has also been a tremendous year for membership growth. Already, as of mid-May, 142 Councils in Florida have achieved their membership goals, representing 43% of our active Councils, and another 69 are within range of making their goals by June 30. As well, 54 of our 86 Districts have also met or exceeded their membership goals. Your commitment to growing the Order has enabled the Florida Jurisdiction to exceed its membership goals on May 9, which, I am told, is one of the earliest dates that has

ever been accomplished! That is certainly not my achievement—it is a result of your collective dedication and successful recruiting efforts! Now, if all 211 of these Councils can meet the other requirements for Star Council, I think we could say this would be one of the best years ever for the Florida State Council!

But we should always remember that this is NOT about the numbers or about getting a plaque for a trophy case. Those of you who have heard me speak on our Spirit of Unity tour know that Star Council goals set by Supreme relate directly to the mission of the Knights of Columbus, and so Star Council is a measure of a Council's success in executing that mission. The more Councils that can achieve those goals, the closer we get to achieving that Spirit of Unity across the Florida Jurisdiction and the Order.

While we take a pause this weekend to celebrate our achievements, we also should recognize that, in the words of one of my brother State Deputies, the end of the Fraternal Year is not a destination, it is a checkpoint. In that vein, I hope that all Council leaders this weekend not only take the time to celebrate your accomplishments, but that you take the opportunity to get new ideas and learn new ways of doing things. To that end, we are, for the first time, introducing workshops into the State Convention. I think we have chosen timely topics-Knights of Columbus Charitable Fund, Cor, Safe Environment, and website training. We know we may not get this entirely right, and so we really want your feedback on these workshops. Ultimately, we want to ensure that we can continue to improve the service we provide to our parishes and our communities.

While we want to continue to conduct and enhance our service programs and charitable works, the upcoming Fraternal Year poses a special challenge. 2024 is, of course, an election year. I don't have to tell you that the polarization and partisanship in our nation is intense, but we must remember that, as Councils and individual Knights, we cannot be involved in partisan politics. This is a very strict rule of the Order. As an individual, of course, one may be involved in partisan politics as a matter of free will, but a person cannot represent himself as a Knight in such activities, nor can Councils as an organization. Even the appearance of involvement in partisan politics must be avoided.

However, having said that, the situation is very different when it comes to nonpartisan issue advocacy, and there is a very grave issue that will be on the ballot in November—namely, the Proposed Amendment 4 to the Florida Constitution which will enshrine unregulated abortion and make Florida one of the most pro-abortion states in the nation. The amendment language is very problematic, using undefined terms

like "healthcare provider", "patient health", and "viability", which will very likely lead to allowance of second and third trimester abortions and take physicians completely out of the picture. And the amendment, if passed, would jeopardize existing laws and prohibit new ones that protect the health and safety of women, and would eliminate parental consent for a minor to have an abortion—which would make abortion the only medical decision for which parents have no say. The Florida Bishops have issued a strong joint statement against this proposed amendment, and all of us here should become familiar with their position.

What is our role as the Knights of Columbus? Quite simply, it is to do everything we can to support our Bishops and our clergy in opposing this amendment. This is truly a lay evangelization mission, and we should take on this mission boldly and confidently, under the leadership of our Bishops. But how do we do this?

First and foremost, our Bishops have asked us to pray, for without prayer, we will accomplish nothing. A specific prayer has been composed, which is already available digitally. You will see prayer cards in your registration packets. I would ask all Knights of Columbus Councils to recite this prayer at meetings and other gatherings, as a constant reminder of what is at stake.

Second, we must promote the reasons why this amendment is wrong. The Florida Conference of Catholic Bishops is starting to publish support materials for Dioceses and parishes to promote opposition to this amendment. At least one

Bishop has already produced a video message on the subject. Let's use those materials in our evangelization efforts to promote opposition to the amendment, particularly among our fellow Catholics.

Third, encourage all Knights—and all Catholics—to register to vote, and to vote "No" to this proposed amendment in November. Nonpartisan voter registration drives have always been a proper Knights of Columbus function.

Finally, in our evangelization efforts, we should also take this opportunity to reflect on why, as Catholics. we oppose abortion. I am certainly the last person to give theological you exposition on the topic, but I can tell you the way I think about it as a lay Catholic.

piece of the ministry of Pope Francis is the concept and ministry of "inclusion" in the Catholic Church. This is not a new concept or even a new ministry. I would make a guess that this concept of "inclusion", when applied to the Catholic Church, is over two thousand years old. To prove this, let us start from the beginning of the Church to understand this concept and ministry of "inclusion".

The concept of the Church was conceived in the Promise of God to Adam and Eve when He promised to send them a Messiah. In that Promise, the seed of "Church" was beginning to take shape and form. In the spectacular event of the birth of Jesus Christ in Bethlehem of Judea, that seed was now planted. It was a seed that was prophesied

by God to the Serpent in the Garden of Eden when God said, "I will put enmity between your seed and her seed, and you shall lie in wait for his heal." In the birth of Jesus, that seed was now planted on fertile ground and ready to blossom as the mustard seed of the New Testament.

In the birth of Jesus, the "Church" was no longer simply a concept, the foundation was now laid by Divine Command in Jesus Christ, true God and true Man. In being true God and true Man, Jesus is the Son of God born of a woman by the Holy Spirit. Being the poorest of the poor, who were the first to hear the announcement that the Messiah was born? You guessed it. It was to a band of poor shepherds tending their flock of sheep. These shepherds were asked by the Angels to venerate Jesus as Messiah and join that fledgling "Church" in its seminal form. When we

This Jesus, in His birth, was poor, born in a stable, and put in swaddling clothes. He was the poorest of the poor by human standards but rich by Divine standards. to fit the first Beatitude of the Sermon on the Mount...."Blessed are the poor in spirit, they shall see the Kingdom of God."

Not only do we have the inclusion of the poor in this fledging Church, but we also see the underlying attitude and spiritual readiness in order to join this new Church. As Jesus and these shepherds, the members of the body of Christ must have an attitude of being poor. The first goal of eternal life is to be poor in spirit, a prerequisite established by the birth of Jesus in a stable.

We see in this humble

beginning of "Church", the beginning of "inclusion". "Church" is for everyone. To prove this, Let us examine the inclusion of the Magi. Even the rich and great are included. The Magi

came looking for the King of Kings. They found Him and were invited into the "Church" founded by Jesus Christ in its infant form in the humble dwelling of Jesus.

After the baptism of Jesus, He began His ministry. Again, what kind of people did He choose to help Him in His ministry? The men He chose, those early Apostles, were poor. They were fishermen and labor workers. After the death of Jesus, Jesus was not finished adding to His band of Apostles, Jesus chose another Apostle, a very learned man by the name of Saul who would soon become known as Paul. After His death, a doctor by the name of Luke, who never knew Jesus personally, joined His disciples and Luke even wrote a Gospel. We can see when Jesus says "Go teach all Nations", all are welcome. What a kadry of people. Talk about inclusion.

After the Ascension of Jesus and the Pentecost event, the apostles went throughout the world building "Church". Those who joined were Jew and Gentile alike. As the Church grew through the ministry of the apostles and those whom they baptized, the Church grew and expanded. The face of the Church included the cultures and traditions of peoples. K John O'Toole wasn't even a candidate for Master of the Florida District of the DeSoto Province at the biennial meeting of the Florida Fourth Degree in April 2020.

O'Toole gave his report as director of exemplars at the meeting - held virtually due to COVID restrictions - and was not even one of the three candidates for the two-year Master position.

You can imagine his surprise when he received a phone call several months later from Supreme Master Stoddard Dennis informing him of his selection.

"I got a call from the Supreme Master, who told me I was new Master." the O'Toole recalled. "I wasn't even running; I didn't even go to the biennial meeting. My wife (Nadine) was sick. She was in the hospital and in rehab,

and this was during

ceremony that was repeated in June and again (in Spanish and English) in October. It wasn't until November that the next live ceremony was held, continuing the Thanksgiving Day Weekend tradition at the Florida Hotel at the Florida Mall in Orlando.

"Virtual degrees were both good and bad," he recalled. "It's so much better if you can experience the Degree in reality, with the color, the music and

> everything. Also, it's a shared experience. You make it with a live group of your brothers, and it means much more. But with virtual. people were able to keep joining. Each council, each assembly was strengthened by that."

O'Toole chaired the 2022 biennial meeting held live in Orlando – and was the only announced candidate. This time. the confirmation call from Supreme Knight Stoddard was not

COVID. Then she died that summer. It was a very difficult time."

Scheduling any live event was difficult at the time, especially a degree ceremony that brought together Sir Knights and Candidates from across the state. Planned Exemplifications in Fall 2020 for Bradenton and Riverview were cancelled due to COVID-related restrictions. Finally, O'Toole's first Exemplification was at St. Sylvester Catholic Church in Gulf Breezes on Feb. 6, 2021. The honoree was the Very Rev. William Wack, CSC, Bishop of the Pensacola-Tallahassee Diocese.

One month later, O'Toole hosted a virtual Exemplification using the Zoom platform – a – just like the State Convention – is brothers

unexpected as O'Toole began his second and final two-year term. With conditions coming back to normal, the Florida District resumed live Exemplifications at locations throughout the state. The 2022 biennial meeting included an idea for a program presented by Assembly 2951 of Apopka involving clipping stars from retired flags and offering them in a small packet to parishioners. Donations were then forwarded to the Gary Sinise Foundation. The program was adapted - with success - by several assemblies throughout the state.

"One of the advantages of the biennial meeting



getting together and sharing ideas. Each assembly gets to hear what other assemblies are doing, and it gives them new ideas for what they can be doing in the future."

In March 2023, O'Toole returned to Gulf Breezes – to host a ceremony while hosting SK Michael R. McKusker – recently appointed Supreme Master of the Fourth Degree.

"I've had a great time as the Master, and I'm glad we were able to transition out of COVID," he said at the recent Florida State Convention. "We made a lot of changes, including the virtual degree, and Florida has shown we produce a great product. I've met a lot of great people I've met across the state at the different assemblies. The Knights of Columbus are a great group of guys, and the Fourth Degree is the cream of the crop – wherever you go."

Following the state convention, O'Toole was planning to return to Guatemala with Monsignor Thomas Skindeleski, repeating a recent trip to help that country recover from hurricane damage.

After that, he will remain active in the Knights and the Fourth Degree.

"I'm more than willing to help with whatever the State wants me to do," he said. "I hope to remain active in the new (Fourth Degree Ceremony), I hope they give me my old job back as Historian. I really enjoyed doing that, and I think I can memorize the new one. I've changed the other degrees four times, and I think I can change to the new one!"

Rosary On The Water



n 10 May 2024, the Straz Center in Tampa, Florida, hosted "Roar the Rosary" with Bishop Gregory Parks from the Diocese of St. Petersburg, Florida; Cardinal Raymond Leo Burke, American Cardinal Prelate of the Roman Catholic Church from Lacrosse, Wisconsin; Mother Adela Galindo, founder of the Religious Order Servants of the Pierced Hearts of Jesus and Mary; Gus Lloyd, Host of Seize the Day on SIRIUS XM's The Catholic Channel. Over 3000 religious and devout Catholics attended the event.

The presentations emphasized the importance of the Holy Rosary, with Mother Adela describing



it as "The Compendium of the Life of Jesus through the eyes of the Blessed Virgin Mary," and Cardinal Burke emphasizing the importance of the Americas' devotion to Our Lady of Guadalupe. Angelic musicians and vocalists, along with Gus Lloyd's narration, added to the spiritual atmosphere. Following the presentations, Cardinal Burke led the congregation in the praying of the Holy Rosary.

Before the praying of the Holy Rosary, the Holy Eucharist was placed into the Monstrance and placed on an altar on the Straz stage. After the Third Decade of the Rosary, a procession was formed with the Holy Eucharist and Monstrance. The entire congregation followed the Monstrance from the Straz Center to the riverfront of the Hillsborough River. The Holy Eucharist was escorted by the Sir Knights Honor Guard of Tampa's Fr. William Tyrrell, SJ, Assembly 0161, consisting of Sir Knights from the Sacred Heart Church Council, the MacDill Air Force Base Our Lady of the Bay Chapel Round Table, and the Christ the King Church Council.

The procession, led by the Sir Knights, navigated through a circuitous and precarious route that significantly narrowed in places and dropped at least 6-10 feet in elevation within 40-50 yards before reaching a barge on the Hillsborough River. The barge then moved up the river and centered

itself on the congregation, reminiscent of biblical passages Luke 5:1-3, Mark 4:1, and Matthew 13:1-3. Through the Eucharist, Jesus ministered to and blessed the 3000+ participants at this deeply moving event.

The Sir Knights of Assembly 0161 considered it an honor and privilege to have served the Lord in the solemn recitation of the Holy Rosary and Hillsborough River Benediction, bringing a meaningful experience to Tampa Bay's Catholic Community.

Florida Bishops Oppose Extreme Abortion Amendment Vote No on Amendment 4

Florida Amendment 4, which will appear on Florida's November 2024 ballot, is an extreme proposal that legalizes fullterm abortion with no protections for the preborn child, including when the child is capable of feeling pain. This proposed amendment to our state constitution would prohibit all restrictions on abortion before viability and create a broad exception that any healthcare provider could exploit to allow abortion up to birth.

Furthermore, the amendment would effectively overturn or seriously jeopardize common-sense state laws that have regulated abortion for years. These include basic health and safety requirements for clinics where abortions are performed, requiring a physician to perform abortions, informed consent requirements, laws limiting public funding of abortion, and parental consent requirements before a minor's abortion.ⁱ These risks demonstrate the extreme nature of the amendment.

We urge all Floridians of goodwill to stand against the legalization of late-term abortion and oppose the abortion amendment. In doing so, we will not only protect the weakest, most innocent, and defenseless of human life among us but also countless women throughout the state from the harms of abortion.

Human life is sacred. The dignity of the human person is the foundation of a moral vision of society. Direct attacks on innocent persons are never morally acceptable, at any stage or in any condition. In our state, human life is repeatedly being destroyed by abortion. Over 84,000 vulnerable and voiceless children were aborted in Florida in 2023.

This matter concerning the respect for human dignity and the fundamental value of human life is of grave importance to both our Church and our state. The threat of abortion remains our pre-eminent public policy priority. Therefore, we support a coordinated campaign to mobilize against the proposed amendment. To this end, we offer this prayer to defeat Amendment 4:

Ever-living God, you give life and desire a future for all your children. Take hold of our nation, state and community and awaken in every heart awe for the gift of life. Send your Spirit to strengthen us with wisdom and fortitude as we defend mothers and children in Florida from laws that disregard their health and safety.

Mary and Joseph trusted in you and welcomed Jesus into our broken world. God Almighty, we ask their intercession to protect the preborn and their mothers, and to guide all parents in raising their children. May they help us build a civilization of love by upholding the sacredness of life and accompanying pregnant women in need.

We ask this through Christ, our Lord. Amen.

Obispos de la Florida se Oponen a la Enmienda Extrema sobre el Aborto Voten No en la Enmienda 4

La Enmienda 4 de la Florida, que aparecerá en la papeleta electoral de la Florida en noviembre de 2024, es una propuesta extrema que legaliza el aborto a término sin ninguna protección para el niño antes de nacer, incluso cuando el niño es capaz de sentir dolor. Esta propuesta para enmendar la constitución de nuestro estado prohibiría todas las restricciones al aborto antes de la viabilidad y crearía una amplia excepción que cualquier profesional de la salud podría aprovechar para permitir el aborto hasta el nacimiento.

Exhortamos a todos los floridanos de buena voluntad a que luchen contra la legalización del aborto tardío y se opongan a la enmienda sobre el aborto. Al hacerlo, no sólo protegeremos las vidas humanas más débiles, inocentes e indefensas entre nosotros, sino también a innumerables mujeres de todo el estado contra los daños del aborto.

La vida humana es sagrada. La dignidad de la persona humana es el cimiento de una visión moral de la sociedad. Los ataques directos a personas inocentes nunca son aceptables moralmente, en ninguna etapa ni condición. En nuestro estado, la vida humana se destruye repetidamente por el aborto. En 2023, más de 84,000 niños vulnerables y sin voz fueron abortados en la Florida.

Este asunto sobre el respeto de la dignidad humana y del valor fundamental de la vida humana es de gran importancia tanto para nuestra Iglesia como para nuestro estado. La amenaza del aborto continúa siendo nuestra prioridad preeminente en la política pública. Por lo tanto, apoyamos una campaña coordinada para movilizarnos contra la enmienda propuesta. 


